Jim Combs, Parks and Recreation Director, introduced Mr. Lyn Corbett, the new City of Sacramento Office of Youth Development Director. Mr. Corbett discussed the new office with Commissioners, including the future roll and interaction with Recreation Services. Commissioners recommended the Office of Youth Development outreach to the County of Sacramento regarding their youth programs and services, be aware of transportation challenges for youth and the potential roll of Regional Transit to help address the issue, to engage in issues relative to designing parks and public spaces to address youth recreation needs, and to plan to outreach and engage the Hmong and Laotian communities.

Greg Taylor, Senior Architect, City of Sacramento Planning Department reviewed the item, emphasizing elements relative to street trees, pedestrian friendly designs, and how guidelines would be incorporated in the City's General Plan Update. Commissioners stressed the need for a specific street tree plan, to incorporate River Friendly landscape designs and maintenance practices, and to maintain large canopy trees on medians as much as possible, given the overhead room for future growth and shade, as opposed to smaller trees that could be planted closer to multi-story buildings.

Director Combs updated the Commission on the status of City planning items they had addressed previously, in addition to park and recreation program and facility highlights.


