# TREE APPLEAL HEARING:

12. APPEAL OF THE DECISION OF THE DIRECTOR OF PARKS AND RECREATION TO DENY A PERMIT FOR THE REMOVAL OF TWO AMERICAN LIQUIDAMBARS (COUNCIL DISTRICT 5)

Senior Deputy City Attorney Michael Sparks, advisor to the Parks and Recreation Commission for Tree Appeal Hearings, stated that he has an economic interest in real property that is directly involved in the Appeal because his property is located within 500 feet of the property owned by the County (the property where one of the Liquidambar trees is located). Mr. Sparks stated that his property is not within 500 feet of Mr. Noto's property (the property where the other Liquidambar tree is located). Mr. Sparks stated that he did not have a conflict of interest that required his disqualification because it is not reasonably foreseeable that the Commission's decision to grant or not grant a permit to cut down the trees would have any impact whatsoever on the value of his property.

Commissioner Price stated that she had the following ex parte communication regarding this case: she asked City staff if the tree roots had interfered with the integrity of the sidewalks; Staff responded the tree roots had not interfered with the sidewalks. Commissioner Williams stated his commute takes him by the site each workday.

Testimony was received from City staff and the appellant, Mr. Noto. Staff circulated a plastic baggy containing seed balls from a Liquidambar tree. Mr. Noto circulated site photos and a plot map of his commercial property, which he retained after the hearing. Commissioners made inquiries and discussed ownership and responsibilities for the trees and sidewalks, condition of the trees and surrounding sidewalks, the tree species and habits, the size and types of trees in the surrounding area, the property owner's maintenance practices, City calls for service including clearing tree debris from storm drains, and recommended methods to reduce tree debris. The hearing was then closed."
