Summary:

Sacramento County maintains a computer system known as the County Criminal Justice Information System (CJIS), and makes access to that system available to authorized law enforcement agencies for a fee. Sacramento Police Department (SPD) accesses mission critical warrant, arrest and known offender data housed in this system. Staff recommends adopting the attached resolution to purchase twelve months of access to CJIS.

Background Information:

The Sacramento County CJIS system houses data critical to the day-to-day operations of the Sacramento Police Department. All county warrants and the court schedule are accessed through this system. Countywide arrests and known offender data can be queried by any authorized agency subscribing to the system and paying an annual fee. Sacramento County Office of Communications and Information Technology (OCIT) collects fees from the subscriber agencies to recover the infrastructure and operating costs of the system. A subscriber agency's annual cost is determined by an analysis of the number of transactions performed by the agency in the last 12 months and the number of agency computers authorized to access CJIS. SPD is careful to limit the number of access points to control both costs and access to secure data.

Financial Considerations:

The total cost for 12 months of access is \$149,340, and will be paid from General Fund Police Department savings through the Public Safety Information Technology Section (Org #2158).

Environmental Considerations:

This proposal does not constitute a "project" and is therefore exempt from the California Environmental Quality Act according to CEQA guidelines Section 15061 (b)(1) and 15378(b)(3).

Policy Considerations:

The recommendation in this report is consistent with Sacramento City Code, Title 3. Also, this request is aligned with the City's Strategic Plan goal to improve and expand public safety.

AUTHORIZING PURCHASE OF ACCESS TO SACRAMENTO COUNTY JUSTICE INFORMATION SYSTEM

BACKGROUND

- A. The Sacramento County Justice Information System (CJIS) houses data critical to the day to day operations of the Sacramento Police Department.
- B. Sacramento County Office of Communications and Information Technology (OCIT) collects fees from the subscriber agencies to recover the infrastructure and operating costs of CJIS.

- Section 1. The City Manager, or a designated representative, is authorized to purchase twelve (12) months of access to CJIS for an amount not to exceed \$149,340.
