REPORTS FROM DIRECTOR OF PERSONNEL

Mrs. Donna L. Giles, Director of Personnel informed the Board that Leaves of Absence have been approved for Gerald A. Sylvia, Dispatcher I and Cristina M. Phoenix, Police Officer.

Mrs. Giles also circulated a pamphlet for the next IPMA Conference to be held in Washington, D.C. and asked the Board Members if there was any interest in serving as a panel member on one of the various committees during the conference.

APPEAL OF RICHARD B. KUPPER - RESCHEDULE SERGEANT WRITTEN TEST

Although he was represented by Counsel Kenneth Hulse, Police Officer Richard B. Kupper spoke for himself in his appeal to reschedule his time to take the Written portion of the Police Sergeant's examination. Mr. Kupper stated that he had spent a considerable amount of money on vacation plans before the examination was announced and that the Police Department had required vacation time to be requested last December. The Sergeant exam was announced in April, 1983.

Thelma Vanesian from staff stated that it should first be determined whether the appeal should be heard on the basis of Rule 1.3 -- whether the Director

of Personnel had abused her discretion in denying the appeal.

Before the Board made its decision to hear the appeal, Mrs. Nance requested that she be allowed to ask questions regarding practices and procedures.

John Worcester from staff stated that the staff had not rescheduled Sergeant candidates, but did so in the case of one Fire Captain exam and regretted it due to many problems that occurred. One of the main problems involved potential contamination. He also stated that the staff is giving the Sergeant exam to a candidate in another city because that candidate was on military leave and that rescheduling was required under Civil Service Board Rules.

Ms. Vanesian further stated that the test was given at two different times on the same day because this was the least busy time for the Sergeant candidates to be on vacations and that 300 Police Officers could not be missing from work at the same time. Mr. Kupper felt that this was a type of contamination because one group of candidates from the 9:00 a.m. session could inform candidates of answers at the 1:00 p.m. session. There would be only an hour's time inbetween the sessions.

More questions were asked by the Board. It was moved by Mrs. Nance and seconded by Ms. Mabbutt that, although Mr. Kupper's circumstances were unfortunate, the Director of Personnel did not abuse her discretion in denying his appeal, and therefore, no hearing should be held.


EXAMINATIONS ANNOUNCED


- a. Plant Operator I #1949
