

MINUTES OF CIVIL SERVICE BOARD
CITY OF SACRAMENTO
SPECIAL MEETING

January 25, 1940

The Civil Service Board met in session in their office at 8:00 o'clock P.M.

PRESENT: Commissioners Cavanaugh, Deise, and Stacy.
ABSENT : None

After reading of the minutes, Mr. Cavanaugh moved that the minutes of November 8, November 20, and December 12, 1939, be approved as read; seconded by Dr. Stacy, thereupon becoming the order of the Board.

REAPPOINTMENT,
JOSEPH T. STACY

Resolution No. 8

Resolution No. 8 of the City Council,
adopted January 5, 1940, reading in part
as follows was read and ordered filed by

the Board:

"NOW, THEREFORE, BE IT RESOLVED that DR. JOSEPH T. STACY be, and he is hereby re-appointed a member of the Civil Service Board for term of six (6) years, ending December 31, 1945."

UNIFORM FIREMAN EX. #136

Mile Run Held
Written Exam. Held
Dates Set for Medicals

The Secretary reported that the one mile race was held November 26, 1929 at the State Fair Grounds in accordance with

instructions of the Board, with the following persons assisting: Messrs. Elmer Congdon, R. Permin Everett, D. Jackson Faustman, Robert McLean, Tom Sloan, and Carl D. Williams. Civil Service Board members Cavanaugh, Deise and Stacy were also present and measured candidates for height prior to each race. This portion of the examination commenced at 10:00 A.M. and ended at 1:30 P.M.

After discussing possible dates, Dr. Stacy moved that the medical examinations be held during the period January 31, 1939 to February 16, 1940, inclusive; seconded by Mr. Cavanaugh and unanimously carried.

January 25, 1940

The Secretary reported that the written portion of this examination was held December 14, 1939, in the Library of the Sacramento Junior College in accordance with the action of the Board. Dr. Stacy was present and R. Permin Everett, Harriet Martin, Katherine Mergell and Birdie Nathan assisted with the examination, which commenced at 7:00 o'clock and terminated at 11:00 P.M.

The Secretary reported that the papers for the written portion of this examination had been corrected and checked, after which Dr. Stacy moved that identification envelopes be opened and that those receiving a passing grade and meeting the qualifications be permitted to continue with the examination; seconded by Mr. Cavanaugh and unanimously carried.

ELECTION OF OFFICERS

This being the time for election of officers, President Stacy asked to be relieved of his position and Mr.

Cavanaugh moved that Leroy Deise be elected as President for the next two year period; seconded by Dr. Stacy, thereupon becoming the order of the Board, Mr. Deise not voting.

Mr. Deise announced that nominations were in order for Vice-president, whereupon Dr. Stacy moved that Bart Cavanaugh be elected Vice-president for the ensuing two years; seconded by Mr. Deise thereupon becoming the order of the Board, Mr. Cavanaugh not voting.

RECREATION LEADER EX. #137

The Secretary reported that this examination was held December 29, 1939 in the Sutter Jr. High School in accordance with the announcement notice. R. Permin Everett, Jackson Faustman, Harriet Martin and Katherine Mergell were present and assisted with the examination, which commenced at 1:30 P.M. and was completed at 4:15 P.M.

JR. CLERK EXAM. #135

Typing Test Held

The Secretary reported that the typing test for this examination was held at

the Sacramento High School January 10, 1940. Mr. Deise was present and Harriet Martin and Permin Everett assisted. The examination commenced at 7:30 P.M. and was completed at 9:20 P.M.

After discussing possible dates for holding personal interviews, Mr. Cavanaugh moved that February 6 and 7, 1940, be dates for personal interview; seconded by Dr. Stacy, and unanimously carried.

CLASSIFICATIONS

A letter from Dr. Herbert F. True, City Health Officer, dated December 12, 1939, requesting that the Board give consideration to employees in his department, was considered by the Board. Dr. True stated that Gladys Clark and Adeline Warner had been performing social service work for a period of over a year very satisfactorily and that their work was similar to that of Mrs. Edith Lindsay. After reviewing occupational records as submitted by Mrs. Clark, Mrs. Mahr, and Mrs. Warner, Mr. Cavanaugh moved that Gladys Clark, Benita Mahr, and Adeline Warner be classified as Social Service Workers; seconded by Dr. Stacy and unanimously carried.

Definition performed by Social Service Workers as reported by Anastasia Miller, Director of Children's Clinic, and Joy Virgilio, Supervising Nurse, and after discussion requested that same be prepared in the form of a Definition.

Date Set for Exam. After reviewing the announcement notice dated January 25, 1940, for this position and after discussion, Mr. Cavanaugh moved that same be approved; seconded by Dr. Stacy and unanimously carried.

After reviewing the duties and the qualifications of an Engineering Aid and the definition dated January 19, 1940, Mr. Cavanaugh moved that the definition for this position be approved; seconded by Dr. Stacy and unanimously carried.

RODMAN CLASSIFICATION

Intention to Abolish

Inasmuch as a classification for
Engineering Aid had been established
including the duties of Rodman, Mr.

Cavanaugh moved that it be the intention of the Civil Service Board to abolish the classification of Rodman and that those now holding such classification be notified; seconded by Dr. Stacy and unanimously carried.

to that of Engineering Aid, Mr. Cavanaugh moved that Clyde Blotter be classified as an Engineering Aid; seconded by Dr. Stacy and unanimously carried.
