

ORDINANCE NO. 1242, FOURTH SERIES.

AN ORDINANCE CHANGING THE DISTRICTS ESTABLISHED BY ORDINANCE NO. 1000, FOURTH SERIES, PASSED DECEMBER 14, 1943, AND ENTITLED: "AN ORDINANCE REGULATING AND RESTRICTING THE USE OF PROPERTY IN THE CITY OF SACRAMENTO; PROVIDING FOR ITS ENFORCEMENT; PRESCRIBING PENALTIES FOR THE VIOLATION THEREOF; AND REPEALING ALL ORDINANCES IN CONFLICT HERewith."

BE IT ENACTED BY THE COUNCIL OF THE CITY OF
SACRAMENTO:

SECTION 1: The following described properties are hereby reclassified from the 2-Family Use District to the 1-Family Use District under provisions of Ordinance No. 1000, Fourth Series:

MORRIS TRACT: Lots 2 to 11 inclusive.
FOLSOM BOULEVARD TRACT: Lots 3 to 14,
24 to 33, 36 to 46, 49 to 59,
64 to 74 and 77 to 87 inclusive.

RANCHO VILLAGE: Lots 1 to 52 inclusive.
DRIVER TRACT: Lots 6 to 13 inclusive.
BRIGHTON TERRACE: Lots 1 to 14 inclusive.

TAHOE TERRACE UNIT NO. 2: Lots 1 to
56 inclusive.

BUCKMAN COURT: Lots 1 to 11, 14 to 24 inclusive.
PARK EDGE TRACT: Lots 1 to 56 inclusive.
LYNCH & HAGEL SUBDIVISION: Lots 1 to
24 inclusive.
TRAINOR VISTA: Lots 1 to 36 inclusive.
ZITO TERRACE: Lots 1 to 11 inclusive.
EDWARD TERRACE: Lots 1 to 21 inclusive.

Lots 1 to 172, inclusive, of RIVER PARK are hereby classified in the 1-Family Use District and Height and Area District "A", respectively.

SECTION 2: The City Clerk of the City of Sacramento is hereby directed to change the maps which are a part of said Ordinance No. 1000, Fourth Series, to conform to the provisions of the Ordinance.


