SUBJECT: ADOPTION OF SPECIFICATIONS AND AWARD OF BID NO. 1753 FOR TRUCKS WITH UTILITY BODIES IN THE TOTAL AMOUNT OF \$163,110.18

Staff recommends that the contract be awarded to Riverview International Trucks Inc., 2445 Evergreen Avenue, West Sacramento, CA 95691, in a total amount not exceed \$163,110.18. Theirs was the lowest responsible bid received as shown in the attached bid tabulation sheet. It is also requested that the City Council authorize subsequent purchases of identical units under the same terms and conditions within 365 days of award providing such purchases have been approved and budgeted by the City Council.

FINANCIAL CONSIDERATIONS:

Funds for this purchase are available in the Fleet and Facility Management Division's FY96/97 budget for new and replacement vehicles.

ENVIRONMENTAL CONSIDERATIONS:

Ongoing administrative and maintenance activities, such as purchases of supplies, equipment or materials which are not made for purposes of a public works construction project, do not constitute a "project" and are exempt from the California Environmental Quality Act (CEQA). CEQA Guidelines, Sections 15061(b)(1), 15378(b)(3).

POLICY CONSIDERATIONS:

This recommendation is consistent with the requirements for competitive bidding as detailed in Title 57 of the Sacramento City Code.

MBE/WBE EFFORTS:

Requests for bid (RFB) were sent to eleven contractors, two of which are Minority or Woman-Owned Business Enterprises. Of the three responses that were received, none was from an M/WBE firm.
