SUBJECT: LIEN HEARING FOR DELINQUENT MAINTENANCE BENEFIT AREA FEES

SUMMARY

This report requests that the Budget and Finance Committee recommend that the City Council adopt the attached resolution which establishes 7:30 p.m., July 10, 1990, in the City Council Chambers, 915 I Street, Sacramento, California, as the time, date, and place for hearing protests, if any, for delinquent maintenance benefit area fees.

BACKGROUND

This report is in accordance with the provisions of the City Code to hear protests and affirm or reject the assessment.

DISCUSSION

The Downtown and Old Sacramento Maintenance Benefit Area fees were billed for the period July 1, 1989 to June 30, 1990. The City Council adopted Resolution No. 90-195 on March 13, 1990 which established the 12th Street Maintenance Benefit Area effective May 1, 1990. Property owners in the 12th Street Maintenance Benefit Area were billed for the period May 1, 1990 to June 30, 1990. Billings which remain unpaid for all Maintenance Benefit Areas are shown on Attachment I.

FINANCIAL DATA

The lien process provides for collection of \$21,271.42 for unpaid maintenance benefit area fees.



It is requested that the Budget and Finance Committee recommend that the City Council adopt the attached resolution which:




