Subject: Award Contract: Sump 66 Pump Station Electrical Improvements (PN: WM86)

Location/Council District:

Sump 66 is near 4871 Florin Perkins at railroad crossing located in Council District 6 (see enclosed map).

Recommendation:

Accept the responsive low bid from J. R. Sharp Construction, Inc. for the Sump 66 Pump Station Electrical Improvements Project (PN:WM86) for an amount not to exceed \$283,000, and award contract.

Summary:

Bids were received from four (4) bidders and opened by the City Clerk on January 11, 2006. J.R. Sharp Construction, Inc. was the lowest responsive bidder with a bid of \$283,000.

Committee/Commission Action: None.

Background Information:

Sump 66 is a drainage sump station that is designed to collect and pump storm drainage into Morrison Creek from drainage Basin #66. As part of the Department's Infrastructure Replacement and Management Program (IRAMP), the outdated electrical switchboard and motor control centers will be replaced. Based on the IRAMP ranking system, this project is a priority rehabilitation and replacement project required to maintain the drainage system in this area and control flooding. The existing metal building will also be replaced with a masonry block building to housing the new electrical control equipment. The site has severe cracks and will be re-paved.

This project was advertised and four (4) bids were received and opened on January 11, 2006. The bids are summarized below:

J. R. Sharp Construction, Inc.	\$283,000
BRC Construction, Inc.	\$308,500
Cal Electric Inc.	\$396,410
Johnson Mechanical Contractors, Inc.	\$399,980

- Staff recommends contract award to J. R. Sharp Construction, Inc. which exceeded the ESBE goals.
- The engineer's estimate was \$259,000.

Financial Considerations:

The total estimated project cost including design, construction, inspection and contingency is \$330,000 based on the J. R. Sharp Construction, Inc bid of \$283,000. As of January 11, 2006, the Sump 66 Pump Station Electrical Improvements (PN: WM86) has an unobligated balance of \$330,640 (425-WM86) which is sufficient to award the construction contract and complete the project.

Environmental Considerations:

The Planning Services Division, Environmental Section, has reviewed the proposed project and has determined that this project is categorical exempt from CEQA under Section 15302 of the CEQA Guidelines. A notice of categorical exemption will be filed with the County Clerk after City Council award of the project.


Policy Considerations:

This action is in conformance with City Code Section, 3.60 Articles I and III, which provides that the City Council may award competitively bid contracts to the lowest responsible bidder.

This report's recommendation is consistent with the City's Strategic Plan Goals of enhancing and preserving the neighborhoods and supporting the economic vitality of the area.

Emerging Small Business Development (ESBD):

This project included participation goals of 20% for emerging and small business enterprises as required by Ordinance 99-007 and Resolution 99-055, relating to ESBD participation goals and policies, adopted by the City Council on February 9, 1999. The responsive low bidder, J. R. Sharp Construction, Inc., exceeded the ESBE goals with a participation level of 87.19%.

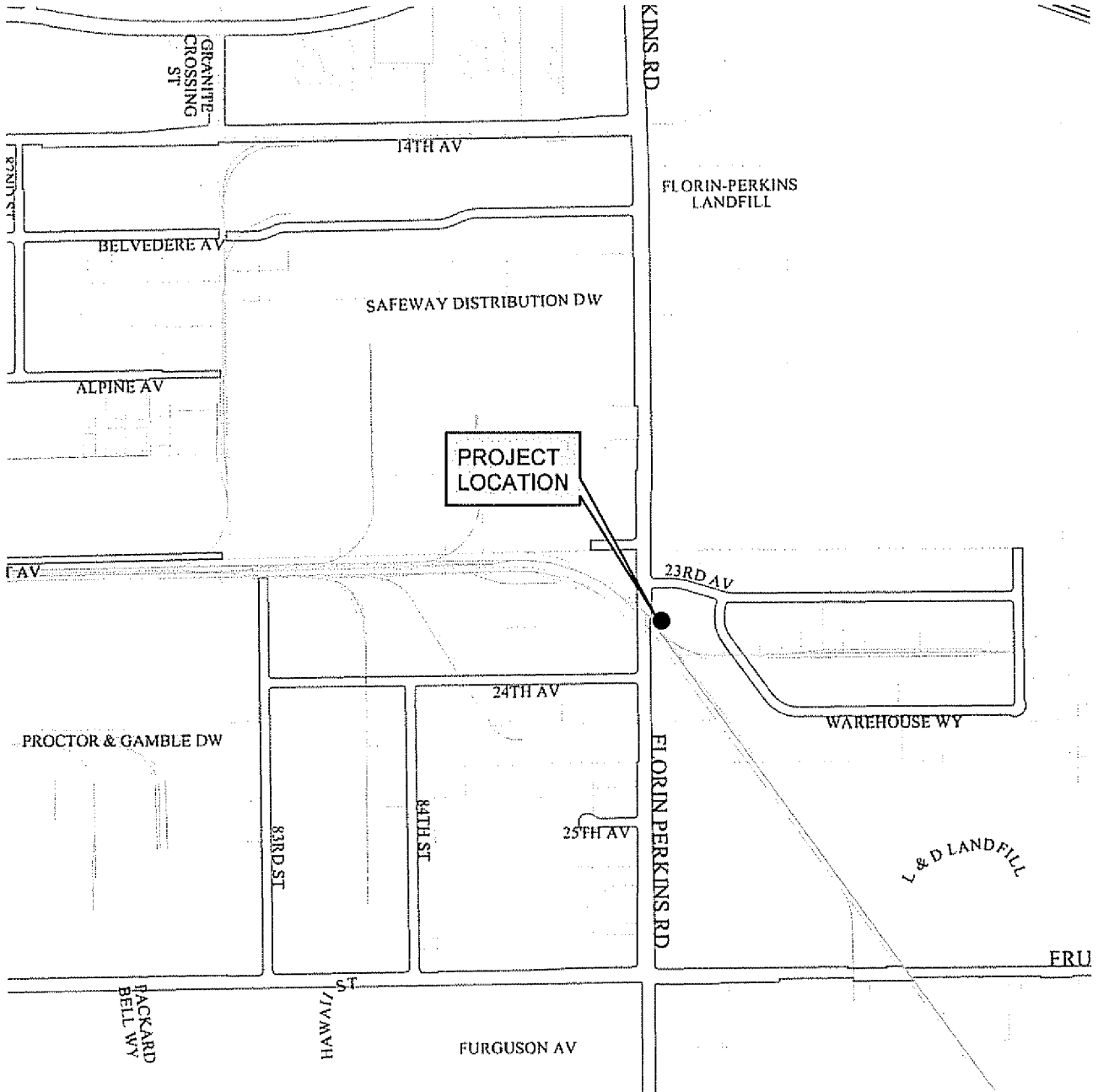

EXECUTE A CONSTRUCTION CONTRACT WITH J. R. SHARP CONSTRUCTION, INC. FOR THE SUMP 66 PUMP STATION ELECTRICAL IMPROVEMENTS PROJECT (PN: WM86) FOR AN AMOUNT NOT TO EXCEED \$283,000

BACKGROUND

- A. Sump 66 is a drainage sump station that is designed to collect and pump storm drainage from drainage Basin #66. Outdated electrical switchboard and motor control centers which are difficult to maintain will be replaced. The existing metal building will also be replaced with a masonry block building to housing the new electrical control equipment.
- B. The project was advertised for bidding and bids were received on January 11, 2006.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City Manager and City Clerk are authorized to sign and execute a construction contract with J. R. Sharp Construction, Inc. for the Sump 66 Pump Station Electrical Improvements (PN: WM86) for an amount not to exceed \$283,000.
