SENATE BILL

No. 1254

An act relating to state-mandated local programs, and declaring the urgency thereof, to take effect immediately.

LEGISLATIVE COUNSEL'S DIGEST

SB 1254, as amended, Ayala. State-mandated local programs.

Existing law requires the state to reimburse local agencies and school districts for the costs of state-mandated local programs.

This bill would provide that all state-mandated local programs, with specified exceptions, enacted after January 1, 1975, are inoperative unless fully funded by the state. It would authorize local governments to implement those programs with their own resources.

This bill would declare that it is to take effect immediately as an urgency statute.

Vote: $\frac{2}{3}$. Appropriation: no. Fiscal committee: yes.
State-mandated local program: no.

The people of the State of California do enact as follows:

1 SECTION 1. Notwithstanding any other provision of
2 law, unless fully funded by the state, all state-mandated
3 local programs enacted after January 1, 1975, are
4 inoperative.

5 This section does not apply to:

6 (a) Legislative mandates requested by the local
7 agency affected.

8 (b) Legislation defining a new crime or changing an
9 existing definition of a crime.

10 (c) Legislative mandates enacted on or after January
11 1, 1975, or executive orders or regulations initially
12 implementing legislation enacted on or after January 1,
13 1975, that affect legislative mandates, executive orders, or
14 regulations implementing legislation that were enacted
15 or issued prior to January 1, 1975.

16 (d) Mandates imposed by the federal government.

17 (e) *Section 54954.6 of the Government Code.*

18 SEC. 2. Notwithstanding Section 1 of this act, local
19 governments may implement those programs with their
20 own resources should full state funding not be provided.

21 SEC. 3. This act is an urgency statute necessary for
22 the immediate preservation of the public peace, health,
23 or safety within the meaning of Article IV of the
24 Constitution and shall go into immediate effect. The facts
25 constituting the necessity are:

26 In order to resolve the state's financial emergency as
27 soon as possible, it is necessary that this act take effect
28 immediately.
