I believe that my experience as a young African American male, and police academy graduate provide unique perspective about the tensions and thought processes of these two groups. Research has shown that people of color are stopped by police officers more often than caucasians, and that males are stopped more frequently than females. Studies also reveal that race is a consistent predictor of attitudes toward police officers.

My interest in this position stems from my background and my belief that I can assist the commission assess the impact of law enforcement practices on Sacramentans of color, how this shapes perceptions of law enforcement, and provide insight to the Council on how to preserve/improve public trust in the police department. I am confident that my law enforcement training, experience, and political sensitivities will add value and provide balance to the important work this commission undertakes.

We have an opportunity, with the revitalization of downtown and building of a new arena to make Sacramento one of the most economically viable cities in California. With that said we have no room in our great city for a racially biased police department. The reality, racial profiling does exist. I don't believe it is a systemic behavior or that it is as widespread within the city of Sacramento as in larger cities, but the fact that it does exist on any level strains the already fractured relationship between our minority communities and law enforcement. We have to work toward rebuilding this relationship. We have to ask and continue asking the hard questions: Is there targeting of minorities during traffic stops; Are minorities afforded fair treatment when interacting with SacPD; Does racially biased policing exist? And if these are issues then then we have to address them head on. We as a collective community have to work on a

resolution that involves all of us, our communities, our local law enforcement and our City Council. My interest in being involved with and a member of the Community Racial Profiling Commission is to continually improve my community and to actively work toward improving relationships with our minority communities and the police department.
