Summary:

In connection with the County of Sacramento's Franklin Boulevard Streetscape and Landscape Project, the County desires to construct improvements on portions of the intersection at Turnbridge Drive that lie within the City's limits. In support of the project, the County desires to declare that portion of the Franklin Boulevard intersection at Turnbridge Drive a county highway for the purpose of rights of way acquisition, construction, maintenance, improvement or repair pursuant to the provisions of Section 1700, et seq. of the California Streets and Highways Code. After completion of the improvements, the western portion of the intersection will revert to the City.

Background Information:

The County of Sacramento is pursuing the Franklin Boulevard Streetscape and Landscape Project to construct roadway improvements along a portion of Franklin

Boulevard. The project involves the installation by the County of a new traffic signal, curb, gutter, sidewalk and sidewalk ramps on Franklin Boulevard at Turnbridge Drive; however, the western half of the Franklin Boulevard intersection at Turnbridge Drive lies within the city limits of the City of Sacramento.

The public interest will be served and it is of general interest to the City that the western half of the Franklin Boulevard intersection at Turnbridge Drive be established as a county highway and that such additional rights of way be acquired as are necessary for construction of roadway improvements, signal improvements, sidewalk and sidewalk ramps pursuant to the provisions of Section 1700, et seq. of the California Streets and Highways Code. The foregoing provisions of the California Streets and Highways Code authorize the county to establish a county highway by taking the steps being proposed herein, such as acquiring rights of way, signal improvements, sidewalk and sidewalk ramps and construction, repair and maintenance of roadway improvements.

The Board of Supervisors of the County has provided by resolution that, upon completion of all improvements on the Franklin Boulevard Streetscape and Landscape Project, it will adopt a resolution pursuant to section 1704 of the Streets and Highways Code to declare the western half of the Franklin Boulevard intersection no longer a county highway. Upon the filing of the County resolution with the City Clerk, the western half of the intersection would no longer be a county highway.

Financial Considerations:

After this intersection is established as a county highway pursuant to this resolution, all costs associated with the acquisition of rights of way, construction, repair and maintenance of street improvements for the project will be covered by the County.

Environmental Considerations:

The County of Sacramento is the lead agency on the project and has completed all California Environmental Quality Act (CEQA) requirements, including adoption of a negative declaration.

Policy Considerations:


This project is consistent with the City Council's Strategic Plan goal to achieve sustainability and livability.

**RESOLUTION OF THE CITY OF SACRAMENTO CONSENTING TO
ESTABLISH A PORTION OF FRANKLIN BOULEVARD
AT THE INTERSECTION OF TURNBRIDGE DRIVE AS A COUNTY HIGHWAY**

BACKKGROUND

- A. The County of Sacramento (hereinafter referred to as "County") is pursuing the Franklin Boulevard Streetscape and Landscape Project (hereinafter referred to as the "Project") to construct roadway improvements along a portion of Franklin Boulevard.
- B. The Project involves the installation of a new traffic signal, curb, gutter, sidewalk and sidewalk ramps on Franklin Boulevard at Turnbridge Drive by the County.
- C. The western half of the Franklin Boulevard intersection at Turnbridge Drive lies within the city limits of the City of Sacramento (hereinafter referred to as "City").
- D. The County desires to acquire rights of way and to construct improvements on the portions of the intersection at Turnbridge Drive that lie within the city's limits in connection with the Project.
- E. The County desires to declare that portion of the Franklin Boulevard intersection at Turnbridge Drive that lies within the City limits a county highway for the purpose of rights of way acquisition, construction, maintenance, improvement or repair pursuant to the provisions of Section 1700, et seq. of the California Streets and Highways Code.
- F. The public interest will be served and it is of general interest to the City that the western half of the Franklin Boulevard intersection at Turnbridge Drive be established as a county highway and that such additional rights of way be acquired as are necessary for construction of roadway improvements, signals improvements, sidewalk and sidewalk ramps pursuant to the provision of Section 1700, et seq. of the California Streets and Highways Code.
- G. The Board of Supervisors of the County has provided by resolution that, upon completion of all improvements on the Franklin Boulevard Streetscape and Landscape Project, it will adopt a resolution pursuant to section 1704 of the Streets and Highways Code to declare the western half of the Franklin Boulevard intersection no longer a county highway, but will remain responsible for the maintenance, improvement or repair.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL
RESOLVES AS FOLLOWS:**

- Section 1. Pursuant to Section 1700, et seq. of the California Streets and Highway Code, City consents to the establishment of that portion of the Franklin Boulevard intersection at Turnbridge Drive that lies within the limits of the City of Sacramento as a county highway for the purpose of rights of way acquisition, construction, maintenance, improvement, or repair.
- Section 2. The portion of the Franklin Boulevard intersection at Turnbridge Drive that lies within the City limits shall be deemed a county highway pursuant to Section 1700, 1701, 1703 and 1704 et seq. of the California Streets and Highway Code, effective immediately upon the adoption of this resolution of consent by the City Council of the City of Sacramento.
- Section 3. Consent of the City is premised upon representations by County that upon completion of all improvements on the Franklin Boulevard Streetscape and Landscape Project, the Board of Supervisors of the County of Sacramento shall adopt a resolution pursuant to Section 1704 of the California Streets and Highways Code to declare the western half of the Franklin Boulevard intersection at Turnbridge Drive no longer a county highway, but will remain responsible for the maintenance, improvement or repair.
