**SUBJECT: FY 1989/90 MAINTENANCE DISTRICT FEES FOR OLD SACRAMENTO**

SUMMARY

This report requests the Budget and Finance Committee to recommend the City Council approve the attached report regarding the fees to be charged during FY 1989/90 for the Old Sacramento Maintenance District.

BACKGROUND

Annually, the City Council is required to determine the levy (for the additional maintenance services) for each property in each maintenance district. Staff has calculated the levy for each property (Exhibit II) in the Old Sacramento Maintenance District, as required by the City Code.

The total cost of the additional maintenance services is \$67,324 and includes daily street sweeping (\$26,087), and continual collection of trash in street receptacles (\$26,185). The property owners that participate in the district, as shown on the attached map (Exhibit III), are notified of the annual assessment. The assessments are made by parcel and range from \$151 to \$3,786 with an average of \$1,122. Eighty-seven (87) percent of the property owners are current on their 1988-89 assessment.

FINANCIAL DATA

The fees levied are used to defray additional City and contractor expenses associated with the higher level maintenance service provided in each area. The proposed expenditures are fully fee supported.

POLICY CONSIDERATIONS

This district was initiated by the property owners in 1984 (See attached resolution Exhibit IV). The property owners pay for the service provided and could discontinue the service if so desired.

MBE/WBE EFFORTS

Not applicable.

RECOMMENDATION

It is requested that the Budget and Finance Committee recommend approval to the City Council the attached report which recommends the fees to be charged during FY 1989/90 for the Old Sacramento Maintenance District.

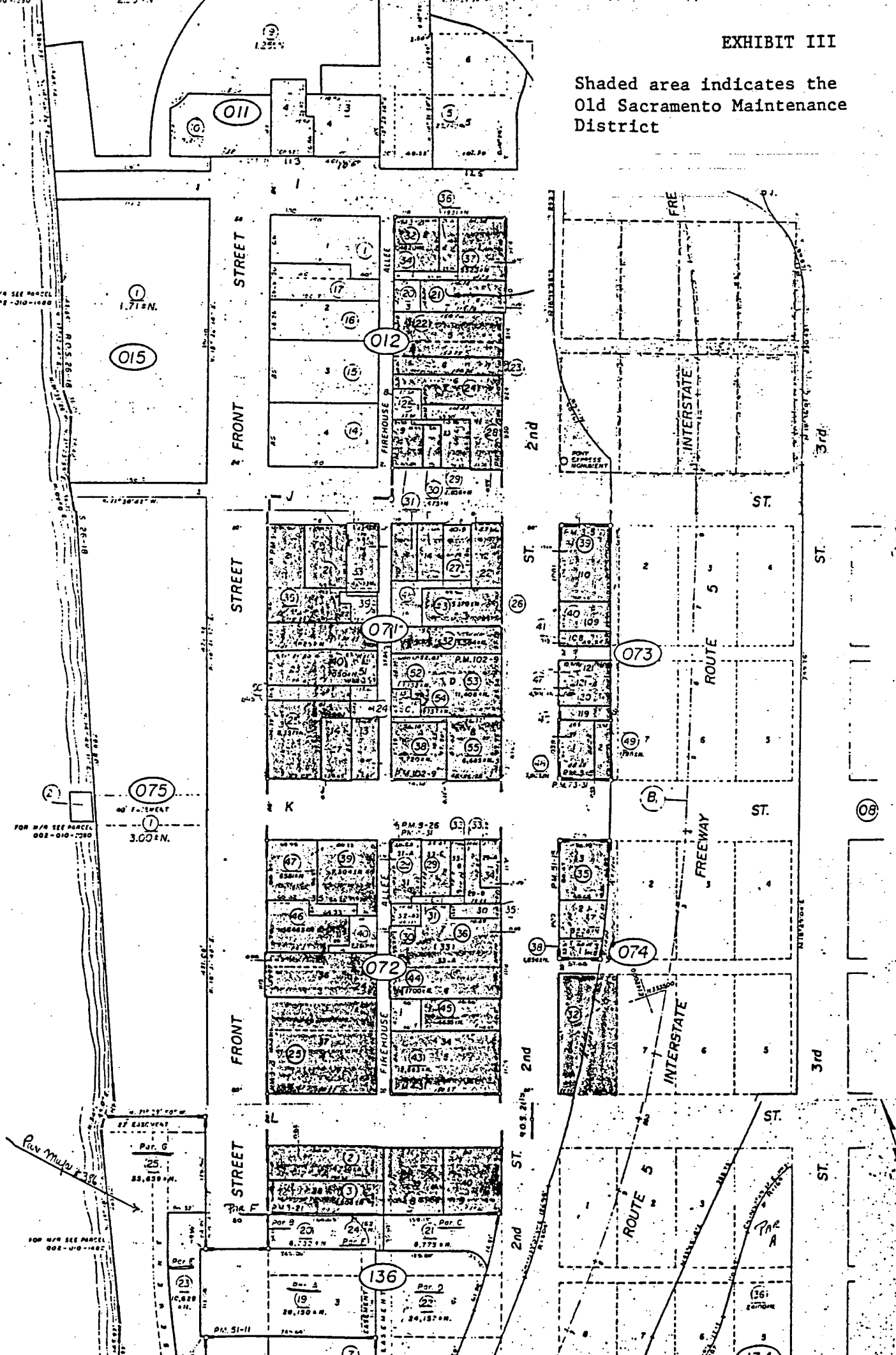

**RESOLUTION ORDERING FORMATION OF  
OLD SACRAMENTO MAINTENANCE DISTRICT**

WHEREAS, on October 2, 1984, this Council adopted its Resolution No. 84-832 declaring its intention to order the formation of the Old Sacramento Maintenance District in the City of Sacramento, County of Sacramento, State of California; and

WHEREAS, this Council in said Resolution set October 23, 1984, at 7:30 p.m. of said day as the time when, and set the Council Chamber of the City Council of the City of Sacramento, in the City Hall of said City as the place where any and all persons having any objections to or protests against the formation of said Old Sacramento Maintenance District might appear and show cause why said Old Sacramento Maintenance District should not be formed as provided in said Resolution; and

WHEREAS, due and legal notice of the time and place of said hearing has been given according to law; and

WHEREAS, no protests were filed against the formation of the Old Sacramento Maintenance District; and

WHEREAS, this Council has heard and considered all the facts that require the City of Sacramento to form said Old Sacramento Maintenance District;

NOW, THEREFORE,

RESOLVED by the City Council of the City of Sacramento, State of California, as follows:

That this Council hereby orders Old Sacramento Maintenance District formed and hereby declares that the boundaries thereof shall be as generally described in "Exhibit A" and as shown on the District map attached hereto and marked "Exhibit B";

Further Resolved that the first fiscal year cost of \$31,909.00 for providing additional maintenance service for the Old Sacramento Maintenance District shall be charged to the owners of the property within the District as a service fee based on the following formula:

- (a) 25% of the fee based on the ratio of each parcel to the total land area within the Old Sacramento Maintenance District;
- (b) 25% of the fee based on the ratio of front footage of each parcel to the total front footage within the Old Sacramento Maintenance District;
- (c) 50% of the fee based on the ratio of square footage per structure or structures on each parcel in relation to the square footage of all structures within the Old Sacramento Maintenance District;
- (d) The sum of (a), (b) and (c), above, shall equal the fee.

Thus, the Council hereby orders the levy of a service fee for the first fiscal year to each of the parcels and structure(s) on each parcel within the Old Sacramento Maintenance District, and said service fee shall be calculated at the rate of \$0.021 per square foot per parcel and \$1.463 per front foot per parcel and \$0.022 per square foot per structure on each parcel for the maintenance of the streets, alleys, and sidewalks. Those parcels of land lying within the blocks bounded by I Street, L Street, 2nd Street and The Embarcadero will have an additional service fee of \$0.007 per square foot per parcel and \$0.525 per front foot per parcel and \$0.007 per square foot per structure on each parcel for the maintenance and cleaning of the service courts.

Further Resolved that the fees to be collected for the first fiscal year of operation of Old Sacramento Maintenance District are set according to "Exhibit C", attached hereto; and

Further Resolved that the date upon which the Old Sacramento Maintenance District will commence to perform its function is January 1, 1985.
