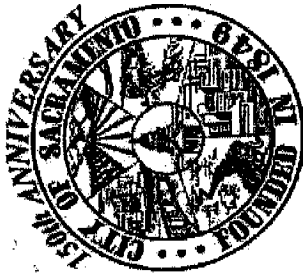

CONDITIONS AND COMMENTS: The new garage meets the setback requirements for the R-1 zone. It is located more than 60 feet from the front property line so it may be constructed on the interior property line. The garage is 4 feet from the main home. Total lot coverage is under 25%. (Home 2013, garage 672, on a 10,800 sf lot.) No other planning issues are apparent.
