

ORDINANCE NO. 1056 , FOURTH SERIES.

AN ORDINANCE AMENDING ORDINANCE NO. 1036, FOURTH SERIES, PASSED JANUARY 26, 1945, AND ENTITLED: "AN ORDINANCE RELATING TO TRAFFIC AND REGULATING THE USE OF PUBLIC STREETS IN THE CITY OF SACRAMENTO; DEFINING AND PROVIDING FOR THE ESTABLISHMENT OF PARKING METER ZONES; REGULATING AND CONTROLLING AND PROVIDING FOR INSPECTION OF THE PARKING OF VEHICLES THEREIN BY THE USE OF PARKING METERS; PRESCRIBING LIMITS OF TIME FOR PARKING IN PARKING METER ZONES; PROVIDING FOR THE ENFORCEMENT OF THIS ORDINANCE AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF," BY ADDING A NEW SECTION THERETO TO BE NUMBERED SECTION 6A, AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1: Ordinance No. 1036, Fourth Series, passed January 26, 1945, is hereby amended by adding a new section thereto to be Numbered Section 6A.

Section 6A:

1. The City Manager is hereby authorized to issue parking meter loading zone hoods to persons, firms or corporations occupying property adjacent to parking spaces located within the parking meter zone, and such persons, firms or corporations are hereby authorized to use such hoods as provided herein.
2. Such hoods shall only be issued, after due application as provided herein, when the circumstances indicate to the satisfaction of the City Manager that there is a need to limit the parking in certain parking areas within the parking meter zone to parking for the purpose of loading or unloading passengers, merchandise or materials during certain times.
3. Application for the issuance of a parking meter loading zone hood shall be made on a form approved by the City Manager.
4. The application form shall require the following information:

- a. Name and address of applicant.
 - b. Name and address of person, firm or corporation occupying the premises adjacent to the parking space concerned.
 - c. The number of the parking meter located at the parking space for which restricted parking is requested.
 - d. A statement of the reasons for the need for such parking restriction.
 - e. The estimated hours of the day during which such restriction may be necessary.
 - f. Such other relevant information as the City Manager may require.
5. The parking meter loading zone hood shall consist of:
- a. A canvas hood of sufficient size to cover the parking meter head.
 - b. Equipped with locking device with the words "Parking for loading only" printed on the hood in lettering as large as the space on the hood will permit.
6. The person, firm or corporation issued a parking meter loading zone hood shall pay the sum of \$8.00 to the Assessor-Collector upon receipt of such hood. Monthly thereafter on the first day of each month such person, firm or corporation shall pay to the Assessor-Collector a sum amounting to the difference between \$8.00 and the amount deposited during the preceding month in the parking meter over which the hood is authorized to be placed. Upon revocation or surrender of the authority to use such hood, no refunds shall be made.
7. The City Manager may revoke the authority granted herein to use such hood for any of the following reasons:
- a. When the person, firm or corporation has failed to pay the fee as provided herein.
 - b. When the City Manager is satisfied that the circumstances no longer require the existence of such authority.
 - c. When the person, firm or corporation is found to be using the hood for other purposes than to fulfill the need for which the authority to use the hood was granted.
8. The person, firm or corporation authorized to use such parking meter loading zone hood shall place such hood over the

head of the parking meter with the lettering facing the street, and shall lock the lock provided on the hood and shall only place or allow such hood to remain on the parking meter during such times as the limitation of parking as provided herein is needed.

9. It shall be unlawful for any person to cause, allow, permit or suffer any vehicle operated or controlled by him to be parked in any parking space within a parking meter zone adjacent to which a parking meter is established while a parking meter loading zone hood is properly in place on the head of such parking meter, unless such parking be while actually engaged in loading or unloading passengers, merchandise or materials, and in no event longer than 30 minutes.


SECTION 2: This ordinance is hereby made an emergency measure and shall take effect immediately; such emergency being that adequate provision for loading is necessary to allow proper enforcement of parking restrictions within the parking meter zone.
