

MINUTES OF CIVIL SERVICE BOARD
CITY OF SACRAMENTO
SPECIAL MEETING

September 13, 1935

The Civil Service Board met in special session in the office of the Board, Room 303, City Hall, at 8:15 P.M., President Deise presiding.

LETTER RE:

A letter dated July 12, 1935, from

APPOINTMENT

Pursuant to the Board's request, the Secretary secured a letter from the City Attorney pertaining to Mr. Jaqueth's date of appointment with the City. The Board had received a letter from Mr. Harland Bartholomew, wherein he expressed his opinion that Mr. Jaqueth was technically employed by the city January 1, 1927, interpretation of which was desired from the City Attorney. City Attorney Hugh B. Bradford's letter dated July 16, 1935, stated that in his opinion Mr. Jaqueth's city service should date from January 1, 1927.

After discussion Commissioner Stacy moved that Mr. Jaqueth's date of appointment be established as January 1, 1927; Seconded by Commissioner Chenu and unanimously carried.
