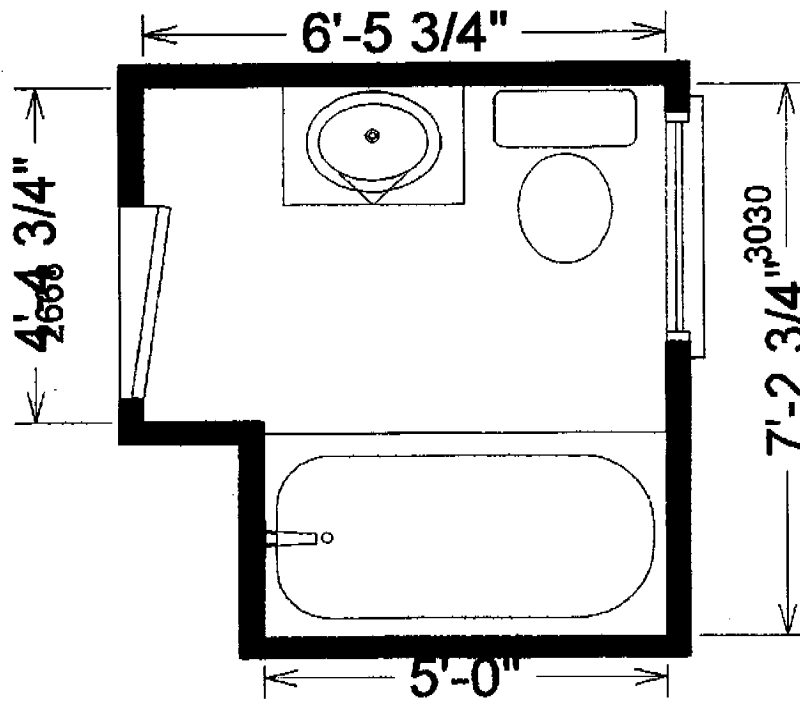

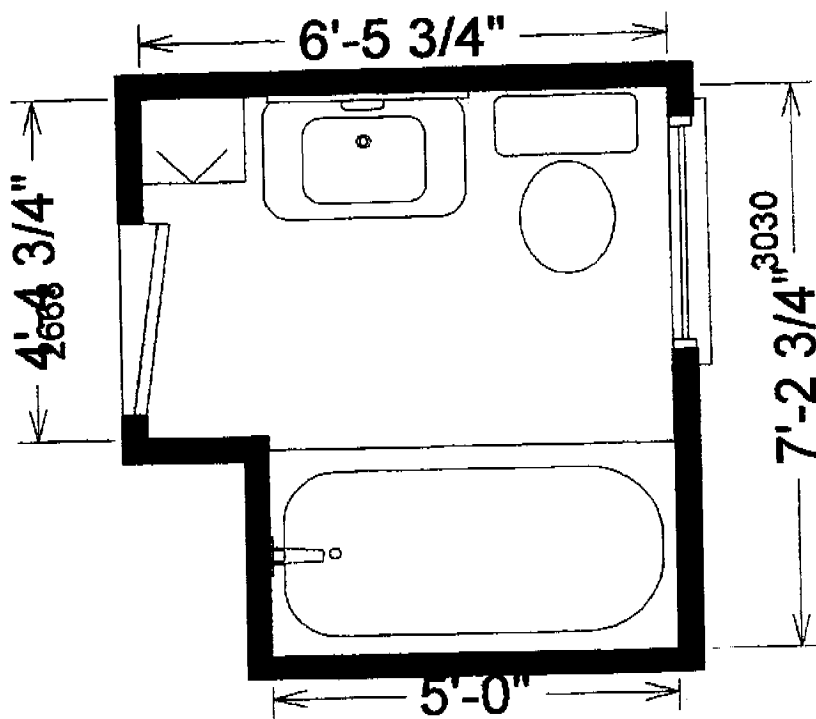

Bushman Existing Bath

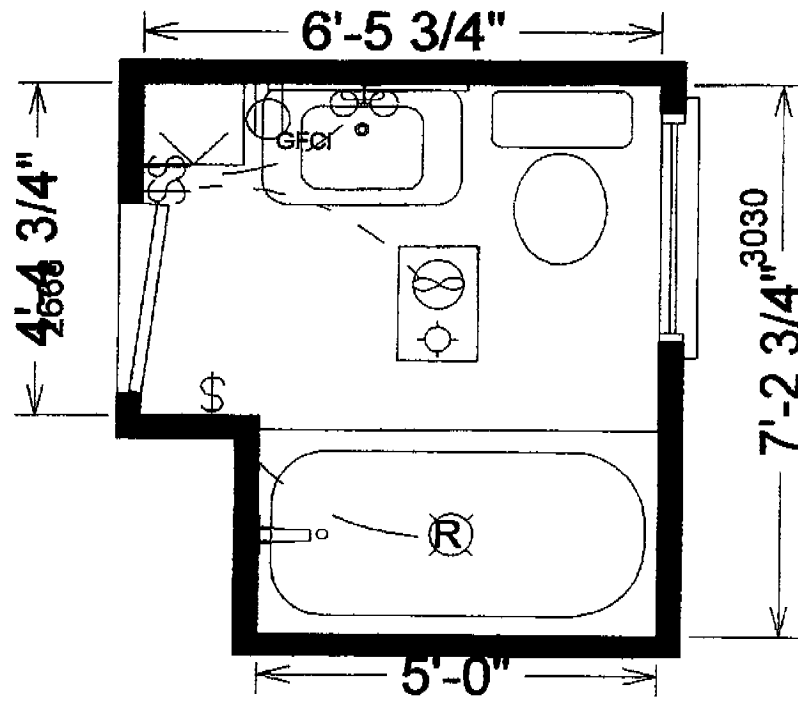
