Subject: Authorization to Purchase Fuel, Equipment and Parts and Services Using
Cooperative Contracts

Location/Council District: Citywide

Recommendation:

Adopt a Resolution: 1) Authorizing the Procurement Services Manager to use State of California, East Bay Municipal Utility District (EBMUD), Sacramento County, and Houston Galveston Area Council (HGAC) contracts to procure fuel, welding services, tires and tire services, original equipment Ford parts, vehicles and equipment with J H. Petroleum, Clean Energy, Interstate Oil, Hunt & Sons, Elmer's Portable Welding, Morgan Tire Co., Folsom Lake Ford, Coalinga Motors, Downtown Ford Sales, Hoblit Motors, International Truck and Engine Corp., Senator Ford, Pearpoint, Inc., Schwarze Industries and Pape Machinery, and 2) authorizing purchases in a combined amount not to exceed \$13,425,000 through December 31, 2007, or until a contract is no longer available. A list of the proposed vendors, contracts, and commodities are listed in Exhibit 1.

Summary:

The City of Sacramento has ongoing requirements for fuel, welding services, tires and tire services, vehicles and equipment and original equipment Ford parts. In accordance with the City Code, the Mayor and the City Council may authorize the use of cooperative government contracts. The use of cooperative contracts is an alternative to

competitive bidding which results in lower operating costs through volume purchasing and combining resources with other government agencies.

This report recommends that the Mayor and the City Council accept the bids obtained competitively by the State of California, EBMUD, Sacramento County, and HGAC, as the basis for awarding City contracts. Further, staff recommends that the Procurement Services Manager be authorized to use those cooperative contracts for the purchase of the aforementioned goods and services when beneficial to participate, in an amount not to exceed \$13,425,000 through December 31, 2007, or until a contract is no longer available.

A list of the proposed vendors, contracts, and commodities is included in this report (Exhibit 1)

Committee/Commission Action: None.

Background Information:

In a constant effort to maximize cost savings and staff resources, many government agencies share contracting efforts through cooperative purchasing or piggybacking. These procurement approaches increase pricing competitiveness and lower operating costs through volume buying. When comparing the administrative costs of procurement, staff considers product research, source selection, specifications, advertising, staff reports, awarding, protest, and administration of the contract. It is often more cost-effective to eliminate the cost and time spent on these administrative processes and purchase items and services through a cooperative purchasing program. The City has used both regional and national cooperative purchasing agreements to compliment its own contracting initiatives. Cooperative purchasing enables City departments and the Procurement Services Division to evaluate a broader range of contracting opportunities and to share resources with other institutions. Cooperative purchasing also leverages internal and external resources to maximize cost saving opportunities for the City.

Financial Considerations:

There are sufficient funds available in the Fleet Management fund for these purchases.

Environmental Considerations: None


Policy Considerations:

The recommendations in this report are in accordance with provisions of the City Code Section 3.56.240, which allows for the use of legal contracts of other government jurisdictions or public agencies without separate competitive bidding by the City upon approval of the City Council.

Emerging Small Business Development (ESBD):

Cooperative Purchasing Agreements are created, evaluated and awarded by other government agencies that may or may not have similar emerging and small business programs. However, the Department of General Services, Fleet Management Division and the Procurement Services Division shall consider other alternatives if it is determined that using cooperative contracts have a negative impact on small businesses

RESOLUTION AUTHORIZING USE OF COOPERATIVE PURCHASE CONTRACTS

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO THAT:

- A. The City of Sacramento has ongoing requirements to purchase fuel, welding services, tires and tire services and original equipment Ford parts, vehicles and equipment contracts. Through the use of cooperative purchasing contracts with the State of California, East Bay Municipal Utility District (EBMUD), Sacramento County and Houston Galveston Area Council (HGAC), the City has an opportunity to obtain lower pricing on these items and services through volume purchasing, and,
- B. Staff requests that the Mayor and the City Council accept the bids obtained competitively by the State of California, EBMUD, Sacramento County and HGAC as the basis for awarding City contracts, in accordance with City Code Section 3 56.240, which allows for the use of cooperative contracts through other governmental jurisdictions or public agencies without separate competitive bidding.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The results of State of California contract numbers 1-05-29-04, 1-06-23-10 and 1-06-23-20, and County of Sacramento contract numbers WA00013505, WA00016830, WA00017078, WA00019279, WA00019302 and WA00019732; and HGAC contract numbers SC01-06 and SW04-06; and EBMUD contract number 216 are hereby accepted for the purchase of fuel, welding services, tires and tire services and original equipment Ford parts, vehicles and equipment contracts; and
