
in the City of Sacramento, be and the same are hereby approved and adopted; and

Resolution of Intention No. 2144

Pursuant to the authority of an Act of the Legislature of the State of California, known as the "Improvement Act of 1911," approved April 7, 1911, and the several Acts amendatory thereof.

It is hereby resolved that it is the intention of the City Council of the City of Sacramento to order the following street work to be done, to-wit:

The improvement of the following in the City of Sacramento:

The alley between "R" and "S" Streets, from the easterly line of 8th Street to the westerly line of 9th Street; by removing and disposing of all surplus and refuse material; placing cast iron street drains, and connecting same to sewer system with vitrified ironstone sewer pipe; constructing vitrified ironstone pipe sewer; reconstructing existing manhole by placing curb and cover to grade; installing one (1) inch connections to City Water Main, in accordance with Ordinance No. 14, 4th Series, of the City of Sacramento; grading; and constructing an hydraulic concrete pavement.

All of said work shall be done in accordance with the detailed plans therefor adopted by the said City Council, and now on file in the office of the City Engineer, and also in accordance with the "Standard Specifications for the Improvement of Streets and Alleys and for the Construction of Sewers," heretofore adopted by said City Council.

Five (5) inch hydraulic concrete pavement shall be constructed as specified in Section 19 of said Specifications; and

Cast iron street drains shall conform to Cut No. 10 of said Specifications.

All persons objecting to said work, are required to file their objections in writing in the office of the City Clerk of the City of Sacramento, as required by law, and notice is hereby given to all persons interested that on the **10th** day of **February**, 192**7**, at **8:00** o'clock P. M., in the Council Chamber of the City Council of the City of Sacramento, in the City Hall, on "I" Street, between 9th and 10th Streets, in said City, any and all persons having any objections to the proposed work and improvement may appear before said City Council and show cause why the proposed work and improvement shall not be carried out in accordance with this Resolution.

And the City Clerk is hereby directed to publish this Resolution twice in the **Sacramento Union**, a daily newspaper, as required by law.




