

MINUTES OF CIVIL SERVICE BOARD  
CITY OF SACRAMENTO  
SPECIAL MEETING

February 5, 1935

The Civil Service Board met in special session in the office of the Board, Room 303, City Hall, at 7:40 o'clock P.M., President Deise presiding.

PRESENT: Commissioners Chenu, Stacy, President Deise.  
ABSENT : None.

The minutes of the meeting of January 9, 1935, were read, and, there being no omissions or corrections, were ordered approved as read.

OLIVER, WILLIAM  
INFORMATION REQUEST

Mrs. Laura Thomas, 514 $\frac{1}{2}$  17th Street,  
sister of Mr. Oliver, a discharged  
employee of the Waste Removal Depart-

ment, appeared before the Board stating that she would like to explain Mr. Oliver's apparent desertion from work August 6, 1934. She stated that he left because of financial worries due to family difficulties and requested the Board to consider permitting his reemployment, inasmuch as Mr. Wm. J. McQuillan, Superintendent of Waste Removal, had submitted a discharge dated August 20, 1934.

After discussion, the Secretary was requested to secure information relative to the case from Mr. McQuillan.

RULES AND REGULATIONS  
FINGERPRINTING AMENDMENT

The Board again reviewed the fingerprinting amendments to the Rules and Regulations as set forth in the

January 9, 1935, meeting.

Commissioner Stacy moved that after this second reading, the Rules and Regulations be amended to include the proposed changes.

LIBRARY EMPLOYEES  
DUTIES

Due to the condition that titles and names of positions given Library employees seemed to be misleading and confusing, the Secretary was instructed to secure a list of each employee's duties and after securing same invite Miss Taylor, City Librarian, to meet with the Board for discussion.

SALARIES OF LINEMEN

A letter from Mr. H. H. Stead, Secretary of the International Brotherhood of Electrical Workers, was read. The letter requested information relative to wages and salaries paid employees working as Linemen for the City. After reviewing wages paid to Linemen in other cities and determining that wages paid Linemen employed by Sacramento were higher than the average, and also that the salary range as established by the City Council of \$155.00 - \$185.00 per month for a six day week and \$140.00 - \$170.00 per month for a five day week permitted a payment of wages similar to, if not greater than, those being paid elsewhere, the Secretary was instructed to provide Mr. Stead with such information.

WHITE, MARY B.  
EMPLOYMENT DATE

The Board considered a letter from Mrs. White, dated January 30, 1935, an employee in the Health Department, stating that she had previously requested information as to her correct date of employment with the City. After reviewing her service record and determining that she had not been absent from work a full year during the period July 24, 1920, to July 1, 1921, Commissioner Chenu moved that Mrs. White be notified that her correct

date of employment be established as July 1, 1915, but that she was not to consider the time July 24, 1920, until July 1, 1921, as counting toward pension or retirement benefits. Seconded by Commissioner Stacy and unanimously carried.

RADIO OPERATOR EXAM. #80  
Review OF PAPERS

The Board carefully reviewed the questions as requested by those who had reviewed their papers. After reviewing all of the papers as requested, the Secretary was instructed to give Paul Farrelle credit for Section 1 of Problem 71 and change his grade accordingly. Other changes were found to be unwarranted.

After reviewing the Eligible Register for Oilers, it was the opinion of the Board that whenever possible the Water Department should employ laid off Operators as Oilers, inasmuch as it had proved impossible to secure Oilers from the list. The Secretary was instructed to so notify the Water Department.
