RETIREMENT HEARING COMMISSION  
SPECIAL MEETING - MAY 8, 1987 - 9:30 A.M.

The Retirement Hearing Commission met in special session in Conference Room 103, 801 - 9th Street, on May 8, 1987 at 9:35 a.m.

RECOMMENDED DECISION OF ADMINISTRATIVE LAW JUDGE REGARDING APPEAL OF HARRY HOGAN FOR INDUSTRIAL DISABILITY BENEFITS  
REJECT DECISION/APPEAL GRANTED

K. William Curtis, Attorney at Law, represented Harry Hogan, who was present. Richard Antoine, Deputy City Attorney, represented the Retirement System Manager.

The Commission received copies of the exhibits submitted and the transcript of the hearing held before the administrative law judge.

Mr. Curtis and Mr. Antoine presented final arguments and rebuttals and answered questions of the Commission.

With approval of the appellant, Mr. Mayberry moved the Commission adjourn to executive session. The motion was seconded by Mr. Koutrouba and was carried by the following vote:

PROPOSED CHANGE TO CITY CODE SECTION 34.1407  
SUPPORT

Richard E. Snyder, Secretary to the Commission, reviewed the recommended proposed change to City Code Section 34.1407 with the Commission, which would permit the recording of retirement appeal hearings by either tape recorder or a certified shorthand reporter. It is proposed that City Code Section 34.1407 be changed to read as follows:

Section 34.1407 Record of oral evidence at hearing

The proceedings at the hearing shall be recorded by a tape recorder or by a certified shorthand reporter.

Mr. Hermocillo moved that the Commission support the proposed change to City Code Section 34.1407. The motion was seconded by Mr. Stamper and carried by the following vote:
