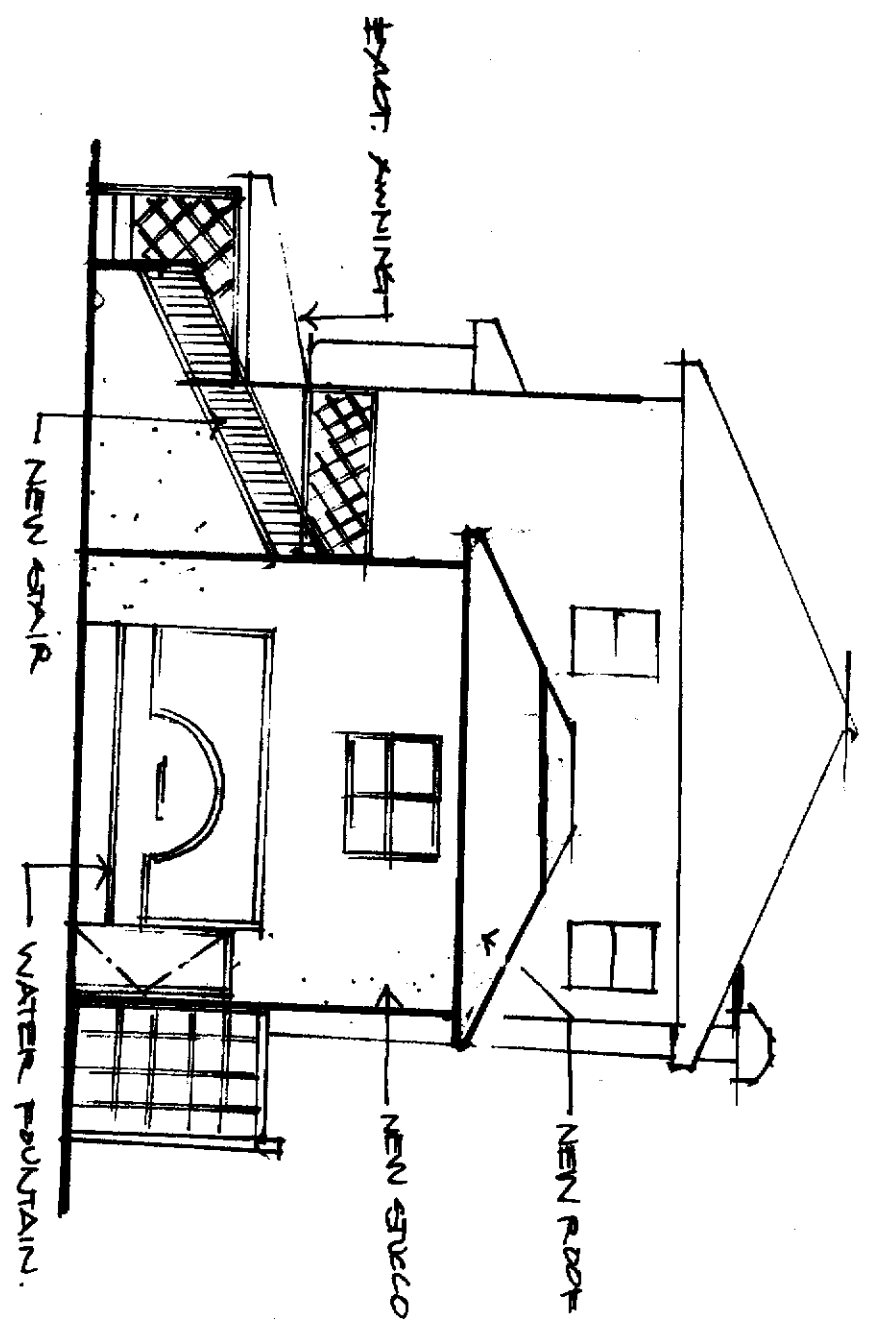
NEW FENCE

**2<sup>nd</sup> FLOOR PLAN**

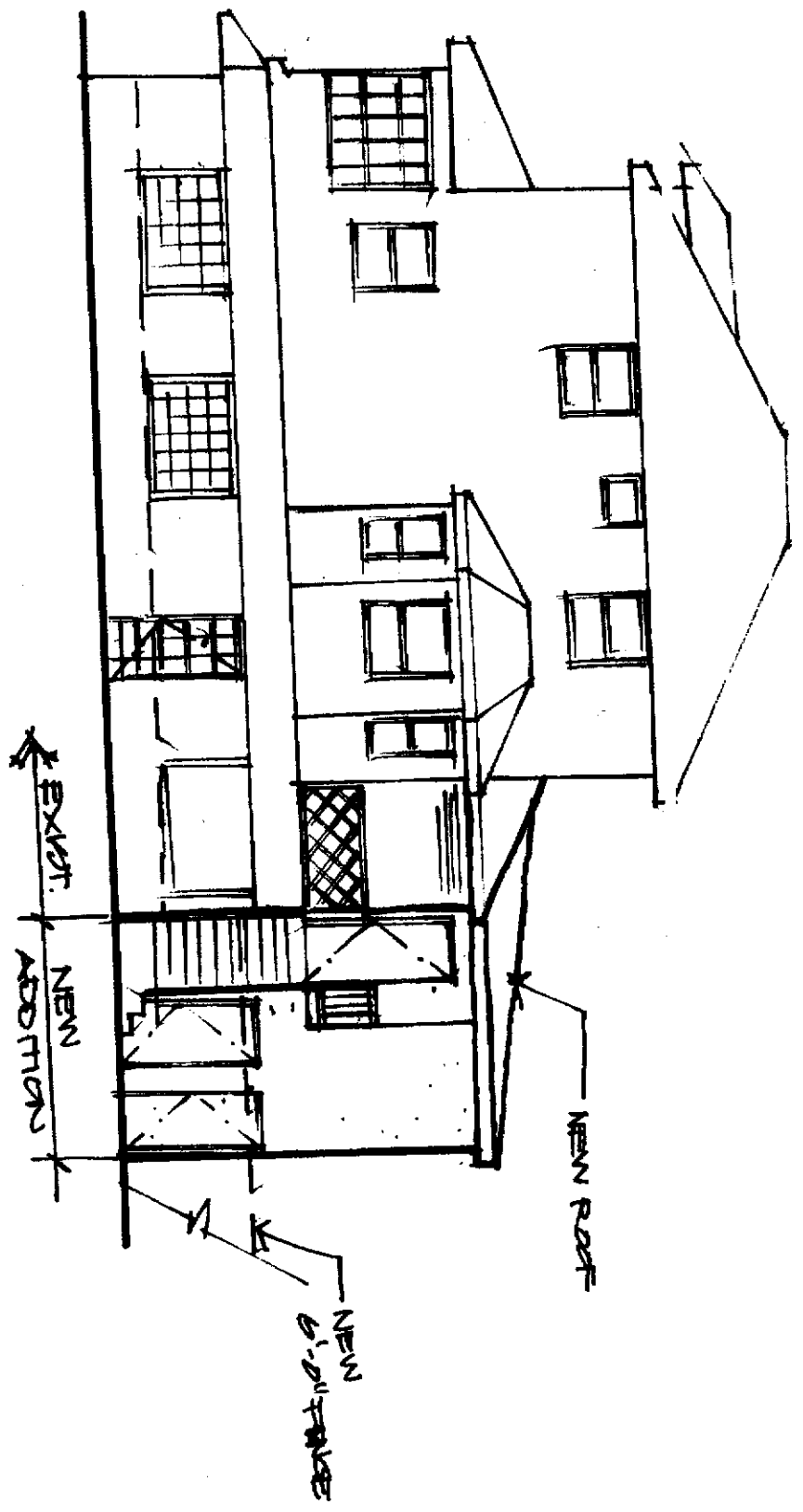

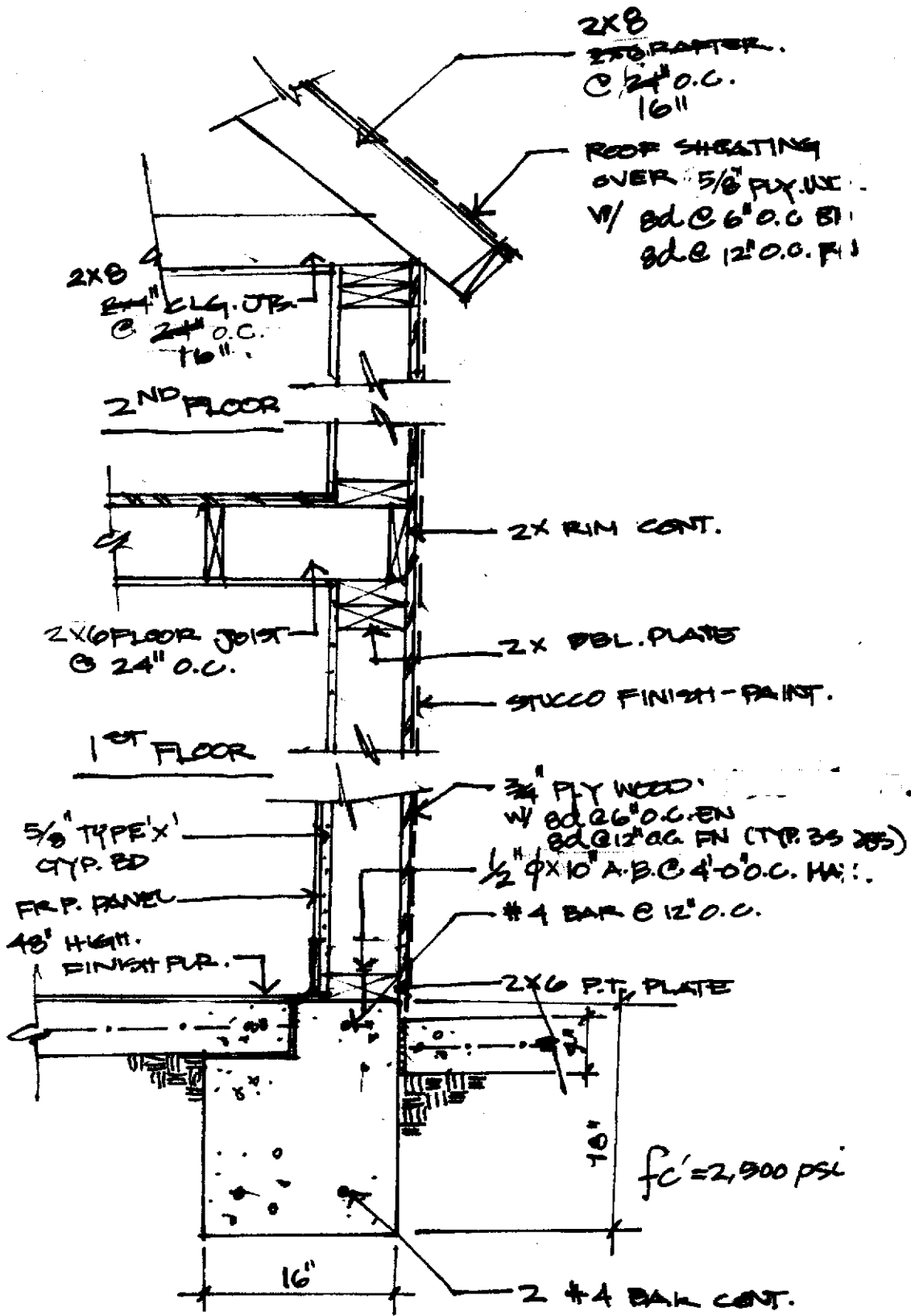

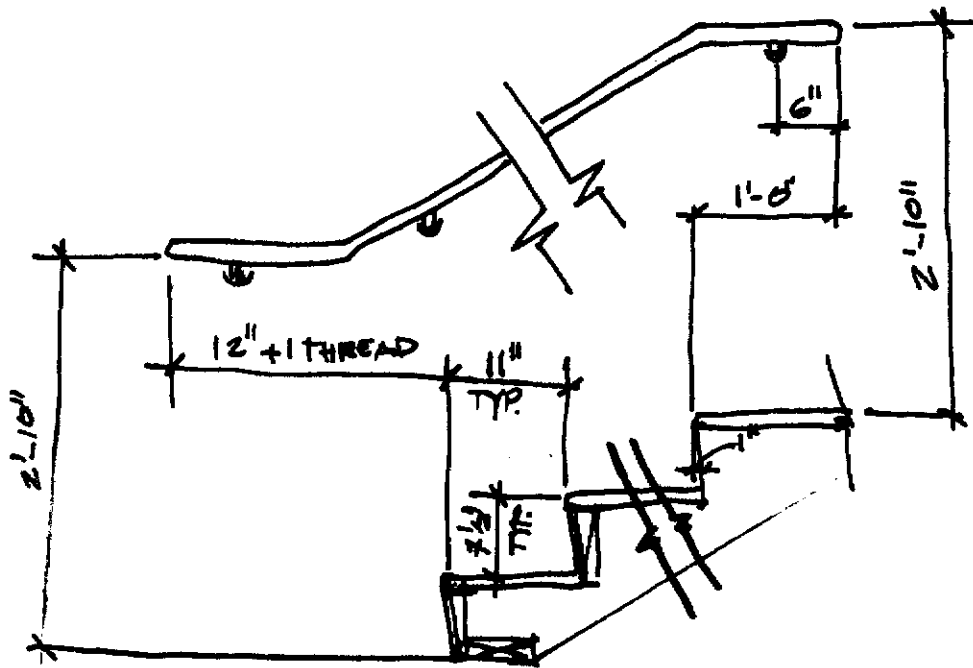




WALL SECTION
