- A. HUMAN RIGHTS/FAIR HOUSING COMMISSION to fill three (3) positions. This opening represents all three (3) seats with term expirations in December 2005. Appointees shall be residents of the City of Sacramento.

- B. SACRAMENTO HOUSING AND REDEVELOPMENT COMMISSION to fill two (2) positions. This opening represents both seats with term expirations in December 2005. Appointees shall be residents of the City of Sacramento.

- C. ANN LAND/BERTHA HENSCHER MEMORIAL FUND COMMISSION to fill two (2) positions. This opening represents both seats with term expirations in January 2006. Appointees shall be residents of the City of Sacramento.
