
I have several qualified Electrical & Lighting persons as well as others who understand the technical workings of sound equipment.

I SHOWS AND PRESENTATIONS and ACTS

- A. For all licensed and Certified Non-Profit Organizations and Churches. The rate is \$7.50 per hour + 5%. This would also include those organizations of the Arts, Ballet, Symphony, Plays and Presentations by Community Organizations.
- B. For all Conventions and Conferences the rate is \$8.50 per hour + 5% Lead men/women at \$9.00 per hour + 5%.
- C. Will provide professional StageHands to work any and all events.
- D. Minimum 6 hours on a call.
- E. Will provide StageHands on a split shift in a 12 or more hour day.
- F. Time and a half after 8-hours of work
 - 1. Rate of pay is Double between midnight and 8:00 a.m.
 - 2. Time and a half on Holidays. (This does not mean weekends unless the holiday falls on the weekend.
- G. Must have a one hour break after 5 hours of work.
 - 1. Will take 1/2 hour break with 1/2 the crew while the rest work if contractor provides hot meal.
- H. All workers will adhere to all rules and regulations governing City Stagehand I and II on pre-show preparation and running off-shows at the Community Center.

II WILL PROVIDE TOOLS, ANY ADDITIONAL EQUIPMENT TO BE PROVIDED BY CITY OR CONTRACTOR.

NOTE: All hours mentioned will be accounted for and documented, any further services and/or arrangements will be made through EDWARD JEFFERSON. (All mentioned will be guaranteed as stated.)
