MINUTES

Cindy Gross, Assistant Planner City of Sacramento, presented this item. She explained that the reason for the change in the Zoning Ordinance is to help Planning make sure that a model home in a new housing complex is indeed a single family home after being used for a temporary office to sell homes.

*Josh Pane arrived at 1:42 P.M.

The fee for the new review process would be \$70. Planning wants to make sure the office is converted into at least a one car garage.

Committee member Fargo stated concern over the landscaping for model homes. The trees should comply to the City list of trees. Also, fencing should either be provided through the entire complex or do not use. The model and its surroundings should not be any different than the homes in the rest of the subdivision.

Committee member Kastanis said that we need a disclaimer placed with any "glitzy" things to make it clear to the consumer that this would not be included with the purchase.

Committee member Fargo asked what provisions had to be made for parking at the model home.

Ms. Gross stated it is not required to have a parking lot at this time. Ms. Fargo would like to check on the possibility of requiring parking lots.

It was MOVED by Committee member Pane and SECONDED by Committee member Kastanis to approve staff recommendation. The motion carried as noted above.


