Description/Analysis

Issue: On September 22, 2009, City Council adopted Resolution No. 2009-604 approving the establishment of a multi-year operating grant for the Youth and Family Services Program.

The program initially was set up as a 'multi-year operating grant', however, because the monies are not from a grant funding source, the Resolution should be corrected to reflect a 'multi-year project' (I02000300). This is an administrative change.

Policy Considerations: Not applicable.

Environmental Considerations: Not applicable.

Commission/Committee Action: Not applicable.

Rationale for Recommendation: Resolution 2009-604 was adopted September 22, 2009, authorizing the establishment of a multi-year operating grant for the Youth. and Family Services Program. Since the source of the fund are generated by the Multi-Family Supplemental Administrative fees collected by the Sacramento Housing and Redevelopment Agency (SHRA), the program is considered a 'project' and not a 'grant' as defined in the Approved Budget book for Fiscal Year 2009-10, Chapter 30 'Resolutions', Section 12. Multi-Year Operating Projects (Resolution 2009-406).

Financial Considerations: In 1999, the City and County adopted policies that require SHRA Mortgage Revenue Bond projects developed by for-profit developers which partner with non-profit organizations to pay a Supplemental Annual Administrative Fee equal to 20 percent of 1 percent of the assessed value. The fees collected can be used to provide services and to offset the loss of property taxes in the jurisdiction where the project(s) are located.

The Multi-Supplemental Annual Administrative Fees are collected by SHRA from various tax exempt Multi-Family Housing projects that receive Mortgage Revenue Bonds. These programs will be funded by the Multi-Family Supplemental Annual Administrative fees. The fees currently generate approximately \$430,000 annually.
