

It is requested that the Committee recommend approval of the attached report to the City Council.



**SUBJECT: ENERGY CONSERVATION ASSISTANCE LOAN PROGRAM  
INTEREST RATE INCREASE**

### SUMMARY

This report recommends that the City advise the California Energy Commission that it wishes to continue with its loan request at the higher interest rate, from 7½% to 8.89%.

### BACKGROUND

On March 25, 1986, by Resolution #86-219 (Exhibit I), City Council authorized and directed the City Manager to execute a loan application between the State of California Energy Commission and the City of Sacramento for a 5-year term loan in the amount of \$76,765 at 7½% interest rate for the Parking Lot K High Pressure Sodium (HPS) Conversion Project.

On May 15, 1986, the California Energy Commission advised all loan applicants that the interest rate will increase from 7½% to 8.89% and apologized for any inconvenience the increase might cause.

The higher interest rate adds \$5,034 to the total loan repayment (see Exhibit II). The City's payback on the loan still remains below 5.0 years (payback @ 7½% - 4.5 years, payback @ 8.89% - 4.8 years) at the current energy rates.

### FINANCIAL DATA

The semi-annual loan payment will remain at \$10,027; however, the final payment will be increased from \$681 to \$5,715, or \$5,034 for the additional interest cost.

The loan payments will be made from the Parking Lots' Operating Budget which will have generated available funds as a result of reduced utility costs because of the HPS Conversion Project.



TO EXECUTE A LOAN APPLICATION  
AND AMEND THE FY 1986-87 PARKING FUND CIP BUDGET  
FOR HPS CONVERSION.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The City Manager is hereby authorized and directed to execute a loan application between the State of California Energy Commission and the City of Sacramento in the amount of \$76,765 for the HPS conversion project in Parking Lot K;
2. That the City budget for FY 1985-86 is hereby amended by increasing the Parking Fund Capital Improvement Project No. 85-1900-001 by \$76,765;
3. That the appropriation increase is to be supported by funds forthcoming from the State of California Energy Commission Assistance State Loan Program; and
4. That the 5-year loan repayment will be made with semi-annual payments of \$10,027 from the Parking Lot Operating Budget 4-12-3183-5037-45XX with funds generated from energy savings.
