SUBJECT: 1994 HAZARD ELIMINATION SAFETY (HES) STREET NAME SIGN REPLACEMENT PROJECT (PN:XXXX/JN:3853) - APPROVE PROJECT, APPROVE CALTRANS PROGRAM SUPPLEMENT NO. 058, APPROPRIATE FUNDS IN AN AMOUNT OF \$300,000 AND BID ADVERTISEMENT

RECOMMENDATION:

This report recommends that the City Council adopt the attached resolution which:

- Establishes the 1994 HES Street Sign Replacement Project (PN:XXXX)
- Approves Program Supplement No. 058 with Caltrans for project design and construction
- Appropriates \$300,000 in Federal Funds for project design and construction
- Approve the plans and specifications for this project
- Authorize the City Clerk to advertise for bids to be received on October 12, 1994.

SUMMARY:

The 1994 HES Street Name Sign Replacement Project will replace existing non-reflective street name signs with high visibility street name signs at various locations throughout the City (see Attachment A).

Street name sign replacement will promote neighborhood revitalization and public safety by making the signs easier to see in low light conditions by citizens and emergency response vehicles.

Approval of the attached Program Supplement No. 058 and establishment of a new capital improvement project enables the City to receive federal funding for the project in an amount of \$300,000. Plans and specifications for the street sign replacement project have been prepared. Approval of the plans and specifications and authorization to advertise for bids is recommended.

COMMITTEE/COMMISSION ACTION:

None.

BACKGROUND INFORMATION:

The street sign replacement project is one of two City projects approved by Caltrans to receive funding under the Hazard Elimination Safety (HES) program of the 1991 Intermodal Surface Transportation Efficiency Act.

The proposed project will upgrade a significant portion (5,000) of the City's 15,000 non-reflective street name signs to highly reflective street name signs. The new signs will help citizens and emergency response teams locate their destinations.

In order to be eligible to receive federal funds, it is necessary for the City to execute a program supplement to the Master Local Agency-State Agreement. A categorical exemption for the project will be filed with the County Recorder of the County of Sacramento immediately after project approval.

FINANCIAL CONSIDERATIONS:

The estimated project cost eligible for federal funding is \$300,000. The City is not required to provide a matching share of funding for this project. It is proposed to appropriate \$300,000 in federal funds (Fund 511) to the new project.

POLICY CONSIDERATIONS:

This action is consistent with City policy and City-State Agreement No. 03-5002 regarding funding of Federal-Aid projects.

Bid advertisement is consistent with Chapter 58, Article III, Section 58.301 of the City code concerning advertisement of bids and Resolution No. 94-130 relating to DBE participation goals and policies adopted by the City Council on March 8, 1994

MBE/WBE:

This project is funded by Intermodal Surface Transportation Efficiency Act (ISTEA) funds. The Federal Government acting through the State of California Department of Transportation (Caltrans) requires that the City set a Disadvantaged Business Enterprise (DBE) participation goal for construction projects funded wholly or in part by any Federal-Aid transportation monies. The DBE category includes both Minority Business Enterprises (MBEs) and Women Business Enterprises (WBEs). This project will include a DBE participation goal of 20% as required by Resolution 94-130 relating to DBE participation goals and policies adopted by the City Council on March 8, 1994.

Award of the contract will be contingent upon the responsive low bidder either meeting the project DBE participation goal or making adequate Good Faith Effort towards meeting the project goal.

Plans and specifications will be sent to seven (7) plan rooms and construction services organizations for publication and use by the construction industry of Northern California. There are four (4) organizations on the distribution list that are directly involved with outreach to MBE/WBE contractors.

Other outreach efforts to MBE/WBEs for this project will include:



Project Description

Project Objectives

- Replace old damaged or deteriorated street name signs
- Replace non-reflective signs with highly reflective street name signs to make signs more visible to citizens and emergency response teams

Existing Situation

Presently, the City maintains 15,000 non-reflective street name signs many of which are damaged or not clearly legible.
