Staff has reviewed the proposed project, and approves it with the following conditions of approval:

- i. Provide two new gridded vinyl windows on south elevation. Provide one new double or single-hung vinyl window on west elevation. Provide one new double or single-hung vinyl window on east elevation. No new windows allowed on north elevation.
2. Refinish remaining original windows. Paint to match trim color.
3. Patch and repair existing stucco siding as necessary. Match existing color and texture.
4. Remove damaged material at eaves. Repair to original configuration.
5. Provide ogee gutters and downspouts throughout.
6. Provide new sills and trim where ever missing. Match original.
7. The scope of work is limited to the above listed items. Any changes are subject to Design Review staff approval.
