

ORDINANCE NO. 1127 , FOURTH SERIES.

AN ORDINANCE AMENDING ORDINANCE NO. 1060, FOURTH SERIES, PASSED JUNE 29, 1945, AND ENTITLED: "AN ORDINANCE APPROPRIATING OUT OF THE REVENUES OF THE FISCAL YEAR COMMENCING JULY 1, 1945, THE AMOUNTS NECESSARY TO MEET THE EXPENDITURES OF THE CITY BASED ON THE BUDGET FOR THE FISCAL YEAR COMMENCING JULY 1, 1945, SUBMITTED BY THE CITY MANAGER, AND MAKING THIS AN EMERGENCY MEASURE," AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO.

SECTION 1: The sum of \$8,965.00 is hereby appropriated to AIRPORT, Budget No. 75, in addition to the sums heretofore appropriated for the 1945-46 fiscal year, to be applied as follows:


