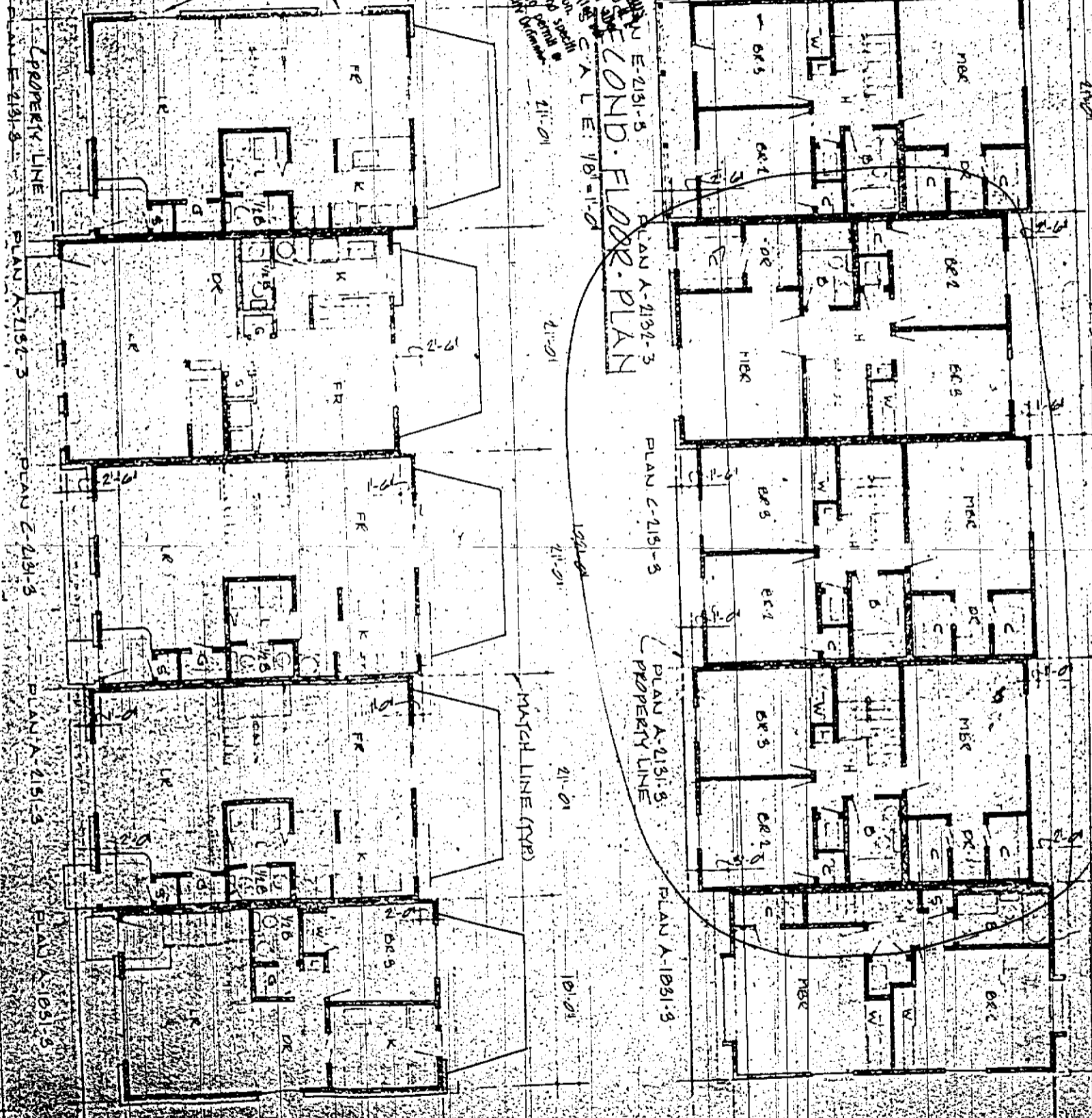

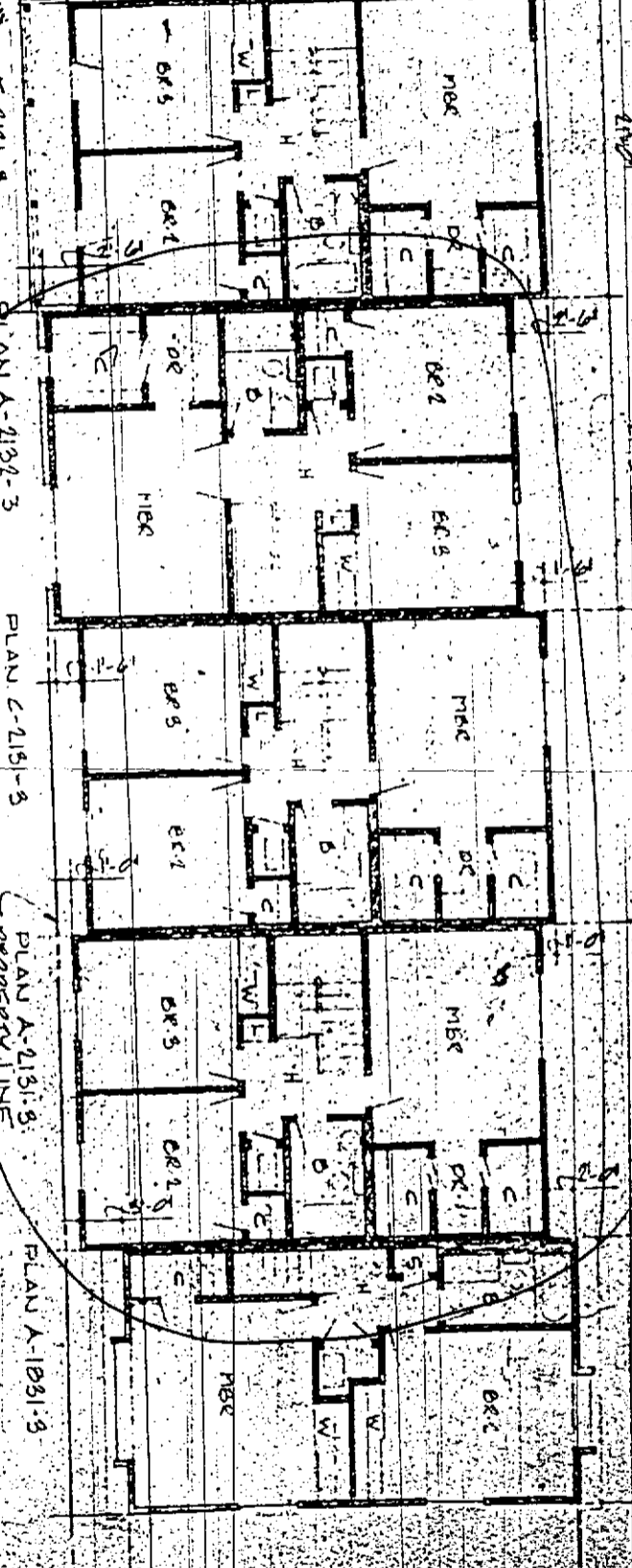
VERIFY WINDOW LOCATION ON EACH END OF DEVELOPMENT PLAN
