**SUBJECT: Metropolitan Arts Division -
Amendment to Artist's Agreement**

SUMMARY

This report recommends approval of an amendment to artist Karen Fenley's agreement with the City for artwork at Riverview Plaza.

BACKGROUND

Artist Karen Fenley is currently under contract with the City of Sacramento to create artwork for Riverview Plaza (City Agreement #86170, \$28,000). The artwork consists of three components: 1) a hanging screen sculpture in the lobby; 2) a hanging chrome sculpture in the dining room; and 3) a hanging painted screen sculpture in the Agora. The amendment is necessary to pay the artist for design changes in the artwork resulting from a modification by the architect of the structural design of the lobby. The attached amendment would revise the total amount paid to the artist. The artist will be paid from the Metropolitan Arts Division's Trust Fund.

FINANCIAL DATA

Funds for this amendment (\$2,437.00) will be forthcoming from the Sacramento Housing and Redevelopment Agency. No City funds are requested.

RECOMMENDATION


It is recommended that the City Council, by resolution, authorize the City Manager to execute the amendment between the City and artist Karen Fenley.
