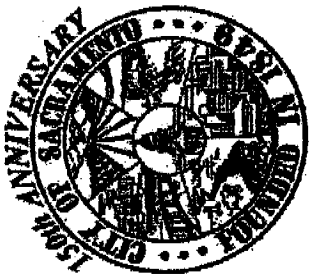

CONDITIONS AND COMMENTS:
Setbacks and lot coverage are okay. Screened covered patio will be 14' from back property line. This is not a patio enclosure as the structure is at least 65% open and there is no glass - just insect screens. Per metroscan, the lot size is 6970, per site plan, existing lot coverage is 1750 + new patio cover 186 = 1936 / 6970 = 28% lot coverage. No Planning concerns.
