- 2) FRAMEWORK TO BE ALL WELDED CONSTRUCTION WITH CONTINUOUS 1/8" - 3/16" FILLET WELDS THROUGHOUT, ALL WELDS TO BE GROUND AND/OR SANDED SMOOTH WHERE CONTACT WITH FABRIC OCCURS
- 3) POWDER COAT FINISH TO MATCH COLOR OF FABRIC
