SUBJECT: Progress Report - Meadowview Community Center Site Selection

SUMMARY

This report provides information on the progress of the site selection process for the proposed Meadowview Community Center. This report is for information only.

BACKGROUND INFORMATION

In adopting the final Capital Improvement Program (CIP) for 1988-93, the City Council included four projects specifically identified by the Budget and Finance Committee. The projects are: (1) the renovation of the Clunie Community Center; (2) a new Belle Coolegge branch library; (3) the expansion of the George Sim Community Center; and (4) a new Meadowview Community Center. The funding plan and the timeline for design and construction of each project was approved. All of the projects are to be completed within five years.

To assist the Department of Parks and Community Services with the Meadowview Community Center project, a fifteen member citizens advisory committee has been formed. This committee, elected by people living in Meadowview, is representative of the various geographical, ethnic, economic, and civic interests of that community. The committee has been meeting monthly since October 1988 to advise this department on the site selection process for the community center. A roster of the committee and an overview of the timeline are attached for your information.

To date, the committee has developed criteria for site identification as well as criteria for ranking each site. The Department anticipates that the timeline as outlined for the site selection process will be completed as scheduled.

FINANCIAL DATA

The funds for purchase of a site have been appropriated in the current year C.I.P. budget. No additional funds are being requested.





COMMUNITY INVOLVEMENT

Representatives from various areas and interests of the Meadowview Community will be involved to advise and assist the Department of Parks and Community Services in the development of the Meadowview Community Center.

Alan Boyd, Recreation Superintendent (449-5171) will be the staff project manager and will be the prime liaison to the community and will coordinate other city staff involved with the project.

OVERALL SCHEDULE

Based on the schedule and funding plan approved by the City Council the following is the general timeline for the development of the Center.

## ADVISORY COMMITTEE

An advisory committee will be formed to assist and advise the Department with the three phases of the Community Center Project. The initial committee will be focused on the selection of an appropriate site for the Center.

The committee will have fifteen (15) people on it representative of the five geographical areas of the Meadowview Community (see attached map). Three people will be selected from each geographical area representative of the diversity of the community. Representation should include people from different age, ethnic and economic interests, and from the various organizations and institutions with an active interest in the Meadowview Community ie: Churches, Schools, Business Groups, Youth Groups, etc.

The committee will be selected/voted on by community representatives from the Meadowview Community and will report back to the total community to keep them informed on the project. Continuation of the membership of the initial committee into the other phases of the project will be determined by the community.

A brief description of each phase of the Community Center project is as follows:

SITE SELECTION: To advise on the selection of a location for the Community Center based on an agreed upon set of criteria:

Committee will meet approximately 4-6 times from October 1988 to April 1989.

DESIGN & CONSTRUCTION: To advise on the design and construction elements of the Center including selection of the architect, the Arts-In-Public-Places Project and the furnishings.

Committee will meet monthly for approximately 12-18 months beginning in July 1989.

PROGRAM & OPERATIONS: To advise on the types of programs/services and operational procedures to be implemented at the Center:

Committee will meet monthly for approximately 12-18 months beginning in January 1990.

### PROPOSED TIME LINE FOR SITE SELECTION PROCESS

#### OCTOBER - 1988

- o Staff Develop Possible Criteria for Site Selection
- o Convene Advisory Committee to:
  - Review entire project
  - Review site selection procedure/process
  - Review and discuss criteria for site selection

NOVEMBER - 1988

- o Committee reviews and approves final criteria for site selection including ranking system.
- o Real Estate Division (City) begins search to identify potential sites.

FEBRUARY - 1989

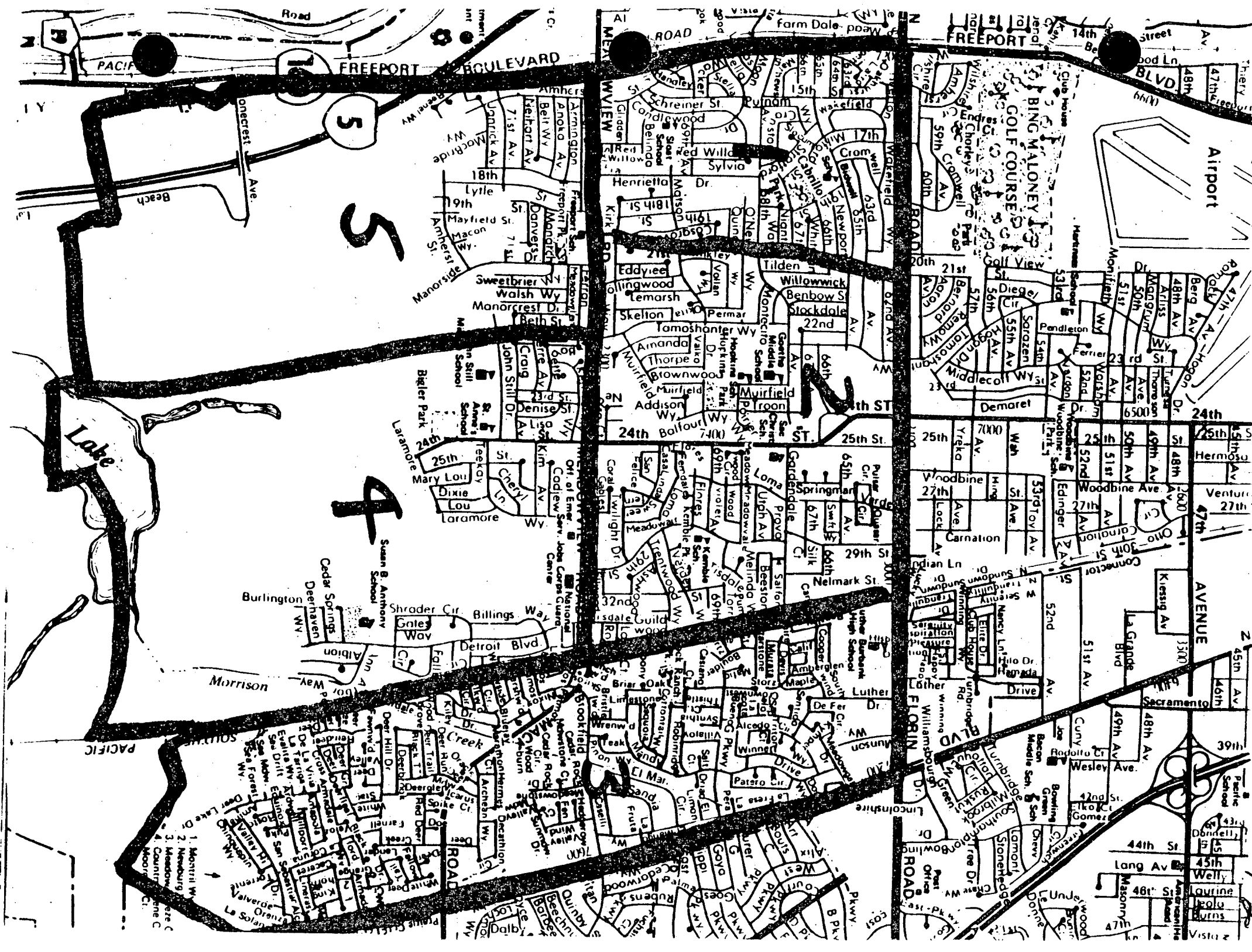
- o Committee reviews proposed sites and ranks them relative to approved criteria.

FEBRUARY/MARCH - 1989

- o Real Estate Division negotiates purchase of site utilizing ranking.

APRIL - 1989

- o City Council approves purchases of site.
