SUBJECT: Amendment to the American River Watershed  
Investigation Cost Sharing Agreement

SUMMARY

The Corps of Engineers has notified the local participants of the American River Watershed Investigation that an additional \$800,000 will be necessary to complete the investigation. The Corps will fund 50% of that cost and the local participants will share in the remaining 50%.

BACKGROUND/FINANCIAL DATA

In the original June 17, 1988 American River Watershed Investigation agreement, the local participants' share of the \$2,500,000 study was \$1,250,000. The local participants are the State of California; Sacramento City; Sacramento County; Reclamation District 1000; American River Flood Control District; Sutter County; and Placer County.

The increase in study costs are due (1) to underestimating the initial project by the Corps and (2) to increasing the scope to include the Freemont Weir.

At the time of the Agreement, the State contributed 53.6% of the local share instead of 50% (i.e., an additional \$35,000) because the other local entities could not fund the cost at that time. The revised cost sharing agreement would result in the State's share being 50%.

The local share of the cost may change if R. D. 1001 is added as a local cost sharer. If that occurs, R. D. 1001 would contribute \$25,000. Staff does not recommend involving R. D. 1001 at this time. The local share will be budgeted in the 1989-90 fiscal year by the Flood Control Planning office with the City's share being funded by the Public Works department.

## ENVIRONMENTAL REVIEW

No environmental review is required at this time.

## POLICY IMPLICATIONS

The proposed action is consistent with the June 17, 1988 Agreement approved by the local participants and their respective governing boards.
