SUBJECT: Oakmont Avenue Water Main (PN:ZC06;JN:9920) - Project  
Approval and Fund Transfer

SUMMARY

Plans and specifications for this project have been prepared. Project approval and fund appropriation is recommended.

BACKGROUND

The residents on the subject street are currently being served by a 3" diameter water main which is undersized and in a deteriorated condition. This project will replace this water main with a 6" diameter water main and provide new water services. The engineer's estimated construction cost is \$20,500.

FINANCIAL

This project is not currently funded. The estimated total project cost, including all planning, design and construction cost, is \$25,000. The 1987-88 Water CIP Program includes \$100,000 for miscellaneous water main improvements. It is proposed that \$25,000 be transferred from the Miscellaneous Water Main fund for this project.


It is recommended that the Budget and Finance Committee approve the transfer of funds and forward the report to the full City Council for project approval and fund transfer.


