SUBJECT: Parks Division Budget Amendment

### SUMMARY

This report provides information regarding the Parks Division's administrative staffing. It is recommended that the Assistant Parks Superintendent position be eliminated and one Administrative Assistant position be added to the FY 1985-86 Parks and Community Services Department budget.

### BACKGROUND INFORMATION

When former Parks Superintendent Gene Robinson retired on February 21, 1986, the City Manager appointed Assistant Parks Superintendent Johnie Bramble to the position of Parks Superintendent. This resulted in a vacancy in the Assistant Parks Superintendent position.

It is necessary to provide the Parks Superintendent with administrative support including budget preparation, project scheduling, personnel and equipment deployment, preparation of written reports and public liaison activities. This support could adequately be provided by an Administrative Assistant I.

The proposed personnel change would result in an annual savings of \$28,290. In addition, this reorganization would contribute to the Parks Division goal of improved management responsiveness to citizens and staff via a reduction in the bureaucratic levels of hierarchy. Management of field operations is the direct responsibility of the two Parks General Supervisors. Elimination of the line supervisory Assistant Superintendent position would result in the Parks General Supervisors reporting directly to the Parks Superintendent.

### FINANCIAL DATA

The proposed staffing change will result in a \$28,290 annual savings to the General Fund.

RECOMMENDATION


