Description/Analysis

Issue: Bids have been received for the 2008 City Street Overlay Project. JA Gonsalves & Son Construction, Inc. is the lowest responsive and responsible bidder. City Council approval is necessary to move forward with awarding the construction contract.


Policy Considerations: This action requested herein is consistent with the Sacramento City Code, Title 3 and with the City of Sacramento Strategic Plan goals of improving and expanding public safety.


Environmental Considerations: The Development Services Department, Environmental Planning Services Division has reviewed the proposed action and determined that the project is exempt from the provisions of the California Environmental Quality Act (CEQA) under Class 1, Section 15301(c) of the CEQA Guidelines. Class 1, Section 15301(c) consists of the maintenance, repair or minor alteration of existing highways, streets, sidewalks, curbs, gutters and similar facilities including road grading for the purpose of public safety.

Rationale for Recommendation: JA Gonsalves & Son Construction, Inc. is the lowest responsive and responsible bidder. Project funding is sufficient to award the contract.

Financial Considerations: As of April 29, 2008, the 2008 City Street Overlay Project (PN: RM81/R15072010) has an unobligated balance of \$929,650 which is sufficient to execute the construction contract in a total amount of \$668,843 with JA Gonsalves & Son Construction, Inc. and cover staff costs for the remaining construction management costs.

Emerging Small Business Development (ESBD): The ESBD goal is 20%. To encourage small and emerging business participation, plans and specifications were sent to 18 plan rooms and construction service organizations for publication. All are directly involved with Emerging and Small Business Enterprise (ESBE) construction firms. The project was also announced on the City's Project Internet site at www.cityofsacramento.org/bids. JA Gonsalves & Son Construction, Inc has achieved 100% ESBE participation.

The 2008 City Street Overlay Project (PN: RM81/R15072010) is part of an annual preventative maintenance program to extend the life of City streets and reduce the need for costly road reconstruction projects. 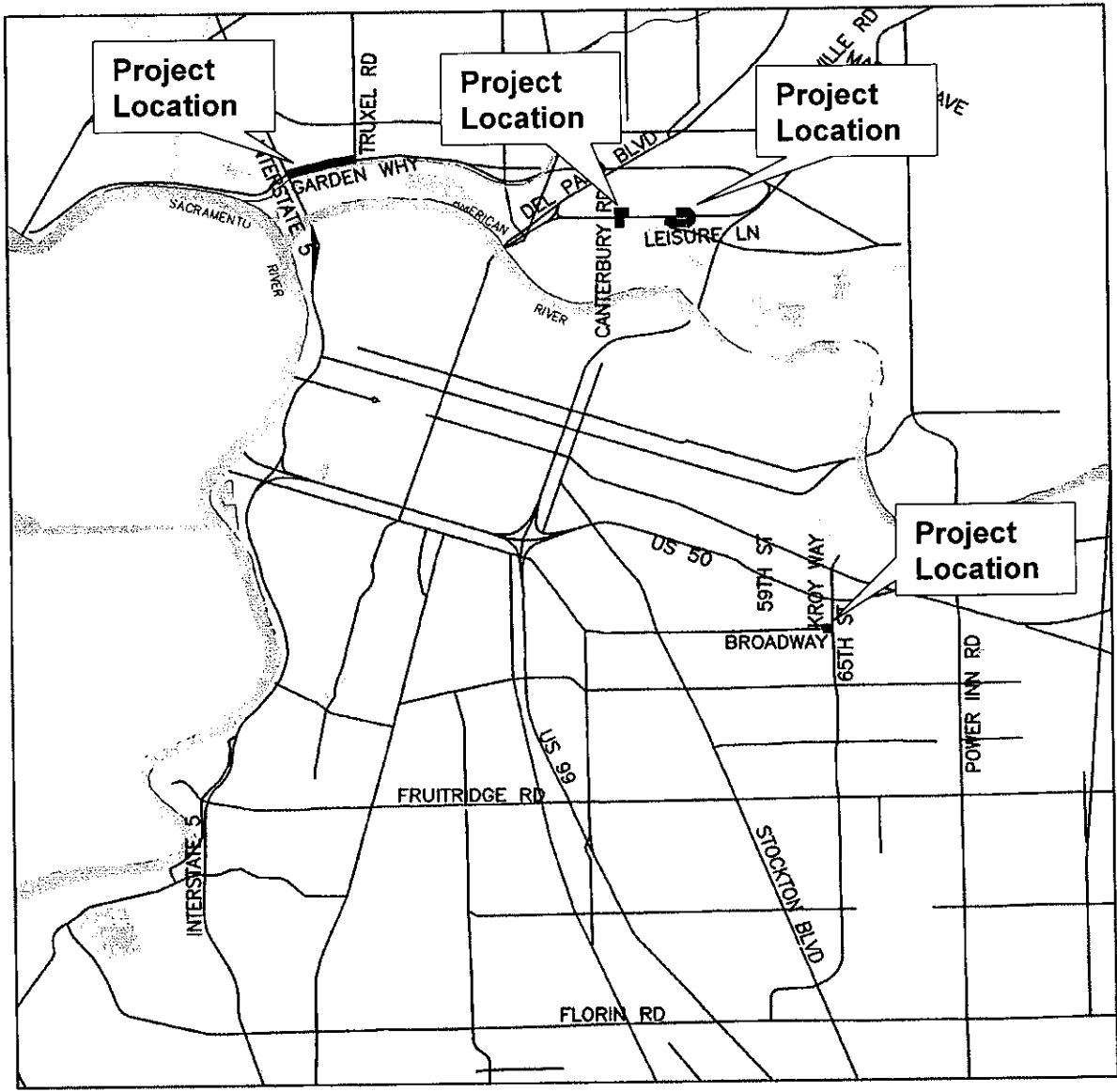
