

MINUTES OF CIVIL SERVICE BOARD
CITY OF SACRAMENTO
REGULAR MEETING AUGUST 14, 1963

The Civil Service Board met in regular session at 817 - 10th Street at 2:00 p.m.

PRESENT: Members C. Alexander, J. Genshlea, F. C. Erickson, W. Street.

ABSENT: Member J. Alexander.

Minutes of the last regular meeting held August 7, 1963, were read and approved.

HEARING TO APPEAL DISCIPLINARY ACTION:

Earthey Dawson
Refuse Collector

The Secretary advised that the date of August 14, 1963, had been set by the Board for

the hearing requested by Mr. Earthey Dawson, Refuse Collector, to appeal the order of discharge given by John Pieretti, Waste Removal Superintendent.

The letter to Mr. Dawson from Mr. Pieretti advising of the discharge action and the reasons therefor, was read. Mr. Dawson appeared before the Board and stated that his appeal of the discharge order was based on the fact that he had worked for the city in the Waste Removal Department for 19 years, and felt that his work had always been satisfactory. Mr. Dawson was questioned at length regarding his record of service, the amount of sick leave time used, days absent without pay for failure to report to work, and prior suspensions.

Mr. Pieretti, Waste Removal Superintendent, advised the Board of his department's policy regarding disciplinary procedures. He stated that Mr. Dawson was granted a 30 day leave of absence in December 1962, at the time Mr. Dawson was arrested on a drunk driving charge and served a 30 day jail sentence, and was warned that any future misconduct resulting in a fine and/or jail sentence would result in more severe disciplinary action being taken. Mr. Dawson was subsequently sentenced to

four months in jail on July 22, 1963, after being arrested for driving a car while his operator's license was suspended, and was thereupon discharged from city service.

Mr. Pieretti was questioned at length regarding Mr. Dawson's work performance and record of service in the department.

The hearing was ordered closed and Mr. Dawson and Mr. Pieretti were excused. Motion was made by Mr. Genshlea that the order of discharge against Mr. Dawson by Mr. Pieretti be sustained. Motion was seconded by Mr. Street and carried by the following vote:


After discussion, it was the order of the Board that Mr. Horn's letter be filed.
