

**RESOLUTION NO. 2005-409**

**FREMONT MEWS: APPROVAL OF NOT MORE THAN \$500,000  
PERMANENT LOAN (CITY HOUSING TRUST FUND/ DOWNTOWN TAX  
INCREMENT); LOAN AGREEMENT, AND RELATED DOCUMENTS WITH 15<sup>TH</sup> & O,  
A CALIFORNIA LIMITED PARTNERSHIP; RELATED BUDGET AMENDMENT**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO:

Section 1: All of the evidence presented having been duly considered, the findings, including the environmental findings regarding this action are approved.

Section 2: The financing of the Fremont Mews project ("Loan") is approved and the Sacramento Housing and Redevelopment Agency is authorized to make a loan to 15<sup>th</sup> and O, L.P., in the amount of \$500,000 and is authorized to amend the Agency Budget to transfer \$500,000 from the City Housing Trust Fund to the Fremont Mews Project.

Section 3: The Sacramento Housing and Redevelopment Agency is authorized to prepare and execute any and all documents required for the making of the Loan (including without limitation the documents necessary for the use of the allocated funds and the documents necessary to make and reasonably administer the Loan); provided, however that Agency Counsel shall prepare the Loan documents that accompanies this resolution; and in accordance with all applicable laws, regulations and policies regarding the making of the Loan and the use of the allocated funds.

Section 4: The Sacramento Housing and Redevelopment Agency is authorized to execute the Loan documents in a form approved by the Agency Counsel and to enter into other agreements, execute other documents, and perform other actions necessary in accordance with their respective terms, and to ensure proper repayment of Agency funds, including without limitation, subordination, extensions and restructuring of payments, all as approved by Agency Counsel.
