SUBJECT: Relocation of Green No. 12 at Haggin
Oaks 18-Hole Golf Course

SUMMARY

This report recommends Council approval to add a project to the Capital Improvement Program for the Golf Division; to appropriate Golf funds for the relocation of the 12th green on the Haggin Oaks 18-hole golf course; and to approve the execution of the agreement between the City and the Sacramento Regional County Sanitation District for the construction of the relocated green.

BACKGROUND INFORMATION

The Sacramento Regional County Sanitation District will be constructing the Natomas Interceptor System which will have one section crossing the Haggin Oaks Golf Course. The alignment of the interceptor has been designed to minimize the loss of trees, maintain the existing drainage and minimize the disruption of golf play during construction. However, the alignment will require the relocation of the 12th green of the 18-hole course. The cost estimate for the construction of the green is \$21,000.

FINANCIAL DATA

The cost of construction of the relocated green will be supported by payment from the Sacramento Regional County Sanitation District, on an advance payment-cost reimbursement basis up to a maximum of \$21,000.

RESOLUTION AMENDING THE CITY CAPITAL
IMPROVEMENT BUDGET FOR FY 1979-80
FOR THE DEPARTMENT OF COMMUNITY SERVICES
(GOLF DIVISION)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The construction of the Natomas Interceptor of the Sacramento Regional County Sanitary System requires relocation of the 12th green of the 18-hole course at Haggin Oaks Golf Course. The relocation project requires an appropriation increase for the budget of the Department of Community Services.
2. The City budget for FY 1979-80 is hereby amended:
 - a. by adding thereto the sum of \$21,000 to the Golf Fund, budget no. 4-18-2230-2112-4820 for the purpose described in Paragraph 1 above.
3. The above appropriation increase is to be supported by an advance payment of \$21,000 that is forthcoming from the Sacramento Regional County Sanitation District, which will be deposited in the Golf Fund.


Gentlemen:
