
RESOLUTION NO. 3264 ORDERING THE

D STREET, 41ST STREET TO LA PURISSIMA WAY.


WHEREAS, it appears from addidavits on file in the office of the City Clerk that NOTICE has been given by mail and by posting as prescribed in Chapter 27, Division 7 of the Streets and Highways Code of the State of California, (IMPROVEMENT ACT OF 1911), setting the time and place when and where objections or protests to the construction of sidewalks on the North side of D Street between 41st Street and La Purissima Way and South side of D Street between 42nd Street and La Purissima Way, according to the Plans adopted heretofore, would be heard by the City Council, and

WHEREAS, no protests have been filed, now, therefore be it

RESOLVED: That sidewalks shall be constructed on said portions of D Street, as specified by the Superintendent of Streets.
