**SUBJECT:** Sacramento Housing and Redevelopment Agency Objectives for 1991

## SUMMARY

As part of our ongoing effort to relate our various activities and budget functions more meaningfully to our program objectives, Agency staff has undertaken to outline for you the full spectrum of our proposed 1991 activities. This report therefore details, with timelines, a complete set of program objectives for the Agency for the balance of 1991. This list includes all facets of Agency operations which go beyond routine functions and relates them to the adopted set of goals which have been approved by the Agency governing boards. You should review and comment on these objectives and timelines and provide additional direction where appropriate.

## BACKGROUND

Last year you adopted six intermediate range (3-5 year) goals for the Agency which included:

- 1) Continued efforts to produce affordable housing countywide.
- 2) A strengthening and expansion of the Agency's role in neighborhood stabilization and preservation.
- 3) A change in focus from subsidization of commercial projects in Downtown to housing and cultural/entertainment facilities.
- 4) Financial stability and leveraging of our resources.
- 5) Improved organization of our social services function.
- 6) Economic opportunity for our tenants.

These goals were reiterated in our 1991 budget and adopted by the Council and Board as the basis for Agency operations in 1991. As a result, we will continue to place emphasis on these areas. Toward that end, we have reviewed each of our program objectives and attempted to group them according to their "fit" with each of the goals identified. That listing, along with the most significant deadline dates (usually the next date at which you can expect to see a report or other observable action relative to each objective surface at your level) and the Agency contact person is summarized in executive format on the pages which follow. (Attachment 1 includes a more detailed timeline for each objective.)

Prior to getting into the list of objectives, it is important to note that they focus mainly on one-time, identifiable events. Most of the Agency's ongoing operations are not listed. Among those are the routine and non-routine maintenance and management of our public housing and the regular operation of our Section 8, elderly nutrition, community information and resident and elderly services programs. Also not included are the regular operation of our child care centers, programs for the homeless, residential rehabilitation programs, homeless shelter and transitional housing operations and routine administration of our Mortgage Credit Certificate, Community Development Block Grant and redevelopment programs including the citizen's participation components. Likewise our labor compliance and Minority Business Enterprise/Women's Business Enterprise efforts, financial services, bill paying, purchasing, and personnel management functions are not included. All of these are ongoing in nature and do not lend themselves to identification as an "objective".

## **FINANCIAL DATA**

Each of the objectives detailed in this report has a financial impact which has either been addressed in a previous report, the 1991 budget, or will be more fully addressed in a subsequent report. Since this report only serves to list and categorize previous actions, no additional financial impact is inherent in it.

## **POLICY IMPLICATIONS**

The six goals and related objectives listed in this report have all been previously discussed from a policy perspective. As noted, our objectives have been categorized to support the policies of affordable housing countywide, neighborhood preservation/stabilization, a change in focus for Downtown away from deep subsidization of commercial projects to housing and cultural/entertainment facilities, financial stability, social services and tenant opportunities.

## ENVIRONMENTAL


