**SUBJECT: APPROPRIATION TRANSFERS FOR CAPITAL IMPROVEMENT PROJECTS**

### SUMMARY:

This report recommends transfer of appropriated funding for Capital Improvement Projects to (1) replace boardwalks in Old Sacramento, (2) provide an energy monitoring and control system for the heating and air conditioning plant at Crocker Art, and (3) remodel a storage area for architects and engineers at the corporation yard.

### BACKGROUND:

Funding adjustments are required for three approved Capital Improvement Projects:

1. \$33,616 remaining from an FY 84-85 Capital Improvement Project for repair of Old Sacramento boardwalks needs to be transferred to a similar 1985-86 project. (This action was previously approved by the Budget and Finance Committee, but a formal Council resolution is required since the transferred amount exceeds \$20,000.)
2. \$55,320 needs to be transferred from operating accounts to permit the contractor, who is constructing the heating and air conditioning plant at Crocker Art

Museum, to provide and install an electronic energy monitoring and control system. The control system will reduce energy and maintenance costs.

3. \$60,000 needs to be transferred from operating accounts for contract remodeling of a storage area at the corporation yard to provide administrative space and a record drawing file area for architects and engineers. Remodeling of the area is more cost effective than leasing or purchasing of trailers.


FINANCIAL:
