NEW EXAMINATION ANNOUNCED

#1480 Associate Planner (Economic Analysis)

After discussing the duties of the Associate Planner class with Mr. Tokuo Masuda, Principal Planner, motion was made by Mr. Wright to approve the examination announcement. The motion was seconded by Mr. Street and carried by unanimous vote.

REQUEST FOR LEAVE OF ABSENCE

Rosie L. Diaz, Intermediate Typist-Clerk

Mrs. Diaz requested a five-month maternity leave of absence (August 23, 1976, through January 21, 1977). Her request had the approval of the Assistant to the Director of Finance and the City Manager. It was the staff recommendation that the requested maternity leave of absence be approved.

Mrs. Kuchman moved to approve the request. Mr. Street seconded the motion which carried by unanimous vote.

PROPOSED AMENDMENT TO STANDARD FOR PERCEPTION OF SOUND FOR POLICE OFFICER -  
second reading

The proposed amendment to the sound perception requirements for Police Officer was presented to the Board, for first reading, at its meeting of August 3.

Sacramento Police Officers Association, through its representative Sergeant Kelley, and Police Chief Kinney endorsed in writing the recommended lowering of the high frequency hearing perception requirement.

Discussion was held concerning the hearing requirements for Firefighter. Mr. Woska reported that Fire Department management did not object to a change in hearing perception if a study of Firefighter hearing perception requirements of other jurisdictions were first conducted. Mr. Woska informed the Board that a similar kind of amendment for hearing perception requirements for Firefighter may be brought before the Board at a later date.


Mr. Wright moved to approve the proposed amendment to the sound perception requirement for Police Officer. Mrs. Hausey seconded the motion which carried by unanimous vote.


The new hearing standards for Police Officer shall read as follows:

PHYSICAL AND MEDICAL STANDARDS  
FOR POLICE OFFICER

- (j) Ears: Both ear drum heads (tympanic membranes) must be intact and ears must be free from infection or other chronic disease. Sound perception thresholds must be between -10db and 30db at frequency levels of 250, 500, 1000, 2000, 3000, and 4000 with audiometer standardized to International Standards Organization - 1964.
