SUBJECT: APPROVAL OF PLANS AND SPECIFICATIONS, ACCEPTANCE OF BID
AND CONTRACT AWARD FOR TAHOE TALLAC PARK PARKING
ALONG SAN JOAQUIN STREET (PN:LK84)

LOCATION AND COUNCIL DISTRICT:

North side of San Joaquin Street along Tahoe Tallac Park. Council District 6.

RECOMMENDATION:

This report recommends that the City Council:

- Approve the plans and specifications;
- Accept the bid of Con-Star in the amount of \$148,815; and
- Authorize the City Manager to execute a contract for the Tahoe Tallac Park Parking Along San Joaquin Street (PN:LK84).

SUMMARY:

This project will widen San Joaquin Street on the North side along the front of the park and provide curb, gutter, sidewalk and handicap ramps along with 90° parking stalls to increase the parking capacity for the park. Street lights will also be included to promote public safety.

BACKGROUND INFORMATION:

- This project was authorized in the 1993/94 Capital Improvement Program.
- This project was advertised and bids were received on March 12, 1997 and are summarized below:

- The construction estimate is \$199,371.
- The contractor met the MBE participation goal and the good faith effort.
- Approval of the plans and specifications and award to Con-Star is recommended.

FINANCIAL CONSIDERATIONS:

- The project budget for Tahoe Tallac Park Parking Along San Joaquin Street is \$210,000.
- The unobligated fund balance as of April 1, 1997 is \$187,739, which is sufficient for award.

ENVIRONMENTAL CONSIDERATIONS:

The Planning Services Division, Environmental Section has reviewed the project and has determined that this project is exempt from the CEQA on October 17, 1996.


POLICY CONSIDERATIONS:

MBE/WBE EFFORTS:


