**APP Committee Minutes
Sacramento International Airport
May 3, 2000**

Meeting called to order by Burnett Miller at 4:05 p.m.

Garr approved the agenda, seconded by Don. Marney approved the minutes of April 5, 2000 seconded by Paulette.

Action Items:

Airport Revised Arts Plan: (This item to be continued.)

APP meeting held at International Airport Terminal A to discuss a revision to the Arts Plan and determine the use of remaining art funds for Terminals B1 and B2, and updates on Terminal A and Parking Garage.

The Committee toured Terminal A to determine if areas existed for potential artworks in the gated areas of Terminal A. While some options for suspended or free -standing artworks exist, the majority of the committee, particularly Burnett, felt that the gated areas and food court were already too busy for additional artwork to be sited. Suggestions were made for small cases at the gated areas with rotating exhibitions (Could use rotating collection -Nancy /Garr), or small suspended elements in the skylights as directional artwork for the gates areas (Bernadette). The committee agreed that APP should wait with any additional artwork in Terminal A and focus on Terminals B1 and B 2.

The Committee suggested that exhibition cases, with rotating artwork, be designed and/or purchased for Terminals B1 and B2. Calls for direct purchase /or commission of cases could be developed. Don suggested types of exhibitions including student artwork, Crocker, crafts, art historical artifacts, etc. Staff will report back to APP Committee with cost options including storage, insurance and installation, possible curator position etc.. All approved this approach. as the primary course of action for the revised arts plan.

Note: Since the APP meeting, Linda Bloom has spoken with Supervisor Roger Dickinson who has suggested that the remaining APP money be used for a combination of sculpture and exhibition cases in Terminals B1 and B2. He intimated that it may be many years until the Terminals will be remodeled and to expect that the artwork could remain in place for at least five years and may be moved later. Hardy Acree, Director of Airports, also verified this information. This item will be discussed at a later APP meeting.

Action Items:

Airport Revised Arts Plan: (This item to be continued.)

APP meeting held at International Airport Terminal A to discuss a revision to the Arts Plan and determine the use of remaining art funds for Terminals B1 and B2, and updates on Terminal A and Parking Garage.

The Committee toured Terminal A to determine if areas existed for potential artworks in the gated areas of Terminal A. Sacramento Metropolitan Arts Commission Announces Available Fellowships
Wilkerson Fellowships for the Technical Arts

Sacramento, California
May 5, 2000

Fellowships for local artists will soon be available through the Fellowship Program of the Sacramento Metropolitan Arts Commission. The Wilkerson Fellowships for the Technical Arts recognize and honor the outstanding contribution of professional artists working behind the scenes, in technical fields related to the visual, performing and literary arts. Disciplines include, but are not limited to, designers, bookmakers, film editors, curators, sound engineers, illustrators, animators and instrument makers. All technical artists who represent the quality and diversity of artistic expression in the Sacramento region are encouraged to apply. (Marketing, advertising, and promotional activities are not eligible.)

The process is nomination-based and competitive. Interested artists may be nominated or nominate another individual. Self-nominations are also accepted, provided that there is sufficient documentation of community support. Applicants are required to live in Sacramento County, work actively in their discipline, demonstrate a body of work, and display a high degree of artistic excellence. Consideration is based on the depth and breadth of the artists' career, including their contribution to the community and the field. The Guidelines and Nomination/Application are available on June 9, 2000, at the Commission office. The application Deadline is July 28, 2000. Free informational workshops will be held June 29, 2000, at La Sierra Community Center in Carmichael at 5:30 p.m.; and July 8, 2000, at Coloma Community Center in Sacramento at 10 a.m. RSVP to 264-5576 to reserve a seat.

The Sacramento Metropolitan Arts Commission is one of the few governmental Commissions in California providing cash fellowships to artists. Sacramento is fortunate to have so many local artists with national and international reputations in their field. The Fellowship program is one way to recognize the diversity and quality of Sacramento's artistic talent. Visual artists were honored in 1995, literary artists in 1996, dance artists in 1997, musicians in 1998 and theatre artists in 1999.

Wilkerson Fellowships

For the Technical Arts, 2000

\$1000 to \$7500 is awarded directly to the artist.

Fellowships are intended to recognize and honor outstanding contributions of Sacramento Artists working behind the scenes in technical fields related to the visual, performing and literary arts. Fellowships are awarded through a competitive process called peer panel review.

Fellowships are awarded to artists who interpret, support and enhance another's artistic vision, production, or individual talent with their artistic contribution, and may teach others to do so.

Disciplines include but are not limited to:

- designers
- conservators
- bookmakers
- illustrators
- animators
- instrument makers
- film editors
- sound engineers

Applicants may be nominated or apply themselves and must be:

- at least eighteen years of age
- an artist actively working in the technical arts and able to demonstrate a body of work
- a resident of Sacramento County during the past three years
