

Sacramento, California,

April 7, 1930.

The Civil Service Board of the City of Sacramento met in special session on the above date, Vice-President Weisman presiding.

PRESENT: Commissioners Maloney and Weisman.
ABSENT : Commissioner Chenu.

The minutes of the special meeting of March 19, 1930, were read and approved as read.

Mr. L. M. Shelley, Judge of the Police Court of the City of Sacramento, appeared before the Board with reference to the position of stenographer in his department now held by Mrs. Rose Fricchette; whom the Board determined at their meeting of March 17, 1930, should be replaced. Judge Shelley explained in detail the requirements of this position and requested that the Board consider reclassifying the position and the retention of the present employee. Commissioner Maloney moved that this matter be laid over. This motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney and Weisman.
NOES: None. ABSENT: Commissioner Chenu.

Mr. Clifford Russell, Attorney at Law, appeared before the Board on behalf of Mr. H. W. Culbertson and requested Mr. Culbertson's reinstatement in the classified service. Mr. Culbertson and Mr. Evans, Superintendent of Parks, were in attendance and were questioned by the Board. Mr. Evans stated to the Board that on the 17th day of January, 1928, that verbally through the City Manager, at that time Mr. H. C. Bottoroff, Mr. Culbertson was granted a leave of absence, and that before 60 days had expired Mr. Culbertson had requested reinstatement. And further that on January 4, 1929,

This motion was seconded by Commissioner Weisman, and the vote was as follows:

NOES: None. ABSENT: Commissioner Chenu.

A communication from Mr. C. R. Blood, Assistant City Engineer, to James S. Dean, City Manager, was received requesting that James Stevens, a Laborer, be given a temporary appointment as Working Foreman, subject to promotional examination. Commissioner Maloney moved that this request be granted. The motion was seconded by Commissioner Weisman, and the vote was as follows:

AYES: Commissioners Maloney and Weisman.
NOES: None. ABSENT: Commissioner Chenu.

A communication was received from James S. Dean, City Manager, relative to the case of Mrs. Lillian Beilby, Stenographer in the Health Department. Mr. Dean requested that the Board reconsider their action taken March 17, 1930, and submitted an opinion from the City Attorney with his request. Commissioner Maloney moved this communication be filed. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney and Weisman.
NOES: None. ABSENT: Commissioner Chenu.

The request of A. M. Gillette asking for a decision as to whether he was in the classified service was next discussed. Commissioner Maloney moved that A. M. Gillette be placed in the classified service. This motion was seconded by Commissioner Weisman, and the vote was as follows:

AYES: Commissioners Maloney and Weisman.
NOES: None. ABSENT: Commissioner Chenu.

The case of F. J. Keegan, Patrolman, was given consideration by the Board. Commissioner Maloney moved that the Secretary be

instructed to reply to the City Manager's request for information in this case and advise him that Mr. Keegan, in accordance with Civil Service Regulations, had lost his present rights to the position he occupied prior to his leave of absence.

The request of Hugh Kunz for reinstatement in the classified service was considered. Commissioner Maloney moved that Mr. Kunz's request for reinstatement be granted. The motion was seconded by Commissioner Weisman, and the vote was as follows:

AYES: Commissioners Maloney and Weisman.
NOES: None. ABSENT: Commissioner Chenu.

A communication was received from H. G. Denton, City Clerk, informing the Board that their recent request for an additional classification; namely, gas and steam roller operator, with a salary range from \$190.00 to \$215.00^{per month}, was adopted by the City Council April 3, 1930. Commissioner Maloney moved that the addition be made to the classified list and the communication filed. The motion was seconded by Commissioner Weisman and the vote was as follows:

AYES: Commissioners Maloney and Weisman.
NOES: None. ABSENT: Commissioner Chenu.

A communication from Dr. J. Howard Hall, Health Officer, to James S. Dean, City Manager, recommending a two months' leave of absence with pay for Miss Anastasia Miller, Superintendent of the Division of Child Hygiene, was received by the Board. Commissioner Maloney moved that this request be approved. The motion was seconded by Commissioner Weisman and the vote was as follows:

AYES: Commissioners Maloney and Weisman.
NOES: None. ABSENT: Commissioner Chenu.

A communication from Manuel Silvera directed to C. R. Blood, Assistant City Engineer, requesting a correction of his date of employment with the City was received by the Board. The present


records showed Mr. Silvera as having started to work May 16, 1913, whereas he claims the first date of appointment was November 1, 1912. This latter was verified upon examination of the pay rolls for this period. Commissioner Maloney moved that the record be corrected to read November 1, 1912. The motion was seconded by Commissioner Weisman and the vote was as follows:

AYES: Commissioners Maloney and Weisman.

NOES: None.

ABSENT: Commissioner Chenu.

Adjournment was taken at 10:30 o'clock P. M. to meet again at the call of the chair.
