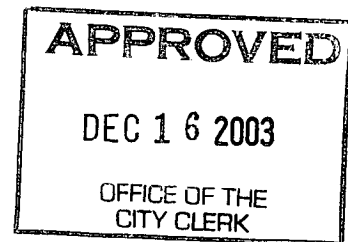

**SUBJECT:** SACRAMENTO REGIONAL COUNTY SANITATION DISTRICT  
ECONOMIC DEVELOPMENT TREATMENT CAPACITY BANK SEWER  
CREDITS FOR TONY'S FOOD FINDS.

**LOCATION AND COUNCIL DISTRICT:** District 1

**RECOMMENDATION:**

It is recommended that City Council approve a resolution awarding Sacramento Regional County Sanitation District (SRCSD) connection fee credits to the described business known as Tony's Food Finds.

**SUMMARY:**

The City of Sacramento's Economic Development Department recommends approval of the attached resolution awarding SRCSD sewer credits to the business known as Tony's Food Finds located at 800 "H" Street (APN: #006-0035-012) at the intersection of 8<sup>th</sup> and "H" Streets. This candidate for sewer credits meets Council-approved criteria for the granting of sewer credits by creating new employment.

**BACKGROUND INFORMATION:**

On March 20, 2001, City Council authorized the City Manager to sign a Memorandum of Understanding (MOU) to initiate City participation in the Sacramento Regional County Sanitation District Economic connection fee credits for award by the City. The MOU

allocated a total of 7,971 Regional Sanitation sewer credits to the City of Sacramento for award by the City to qualifying development projects.

Approval of the MOU followed prior action by the City Council to approve Resolution No. 2000-539 on September 12, 2000, which established the guidelines and criteria by which credits would be granted. On July 18, 2002, Resolution 2002-498 amended those guidelines to read as follows:

- A. A prospective project must meet at least one of the following criteria:
  1. Projects in redevelopment, CDBG and/or infill development areas.
  2. Projects located in neighborhood commercial corridors identified in the adopted City Economic Development Strategy.
  3. Projects located at a targeted key development opportunity site identified in the adopted City Economic Development Strategy.
  4. Projects that create additional employment.
  5. Catalyst projects such as restaurants or high job creation projects that will further economic development.
- B. Projects falling under any of the following criteria may be disqualified from receiving credits from the Economic Development Treatment Capacity Bank:
  1. Projects where the applicant is changing locations within the City of Sacramento without creating any new job opportunities.
  2. Projects that will be owned and/or operated by a jurisdiction that is a member of the Economic Development Treatment Capacity Bank.
  3. Projects that are relocating from a neighboring jurisdiction that is a member of the Economic Development Treatment Capacity Bank.
  4. Projects that add more undesirable uses to an already saturated area (Undesirable uses defined in an Urban Master Plan, Streetscape plan or Special Planning District).
- A. Low to moderate housing located in one of the following geographical areas:
  1. Areas identified in the City's Infill Development Policy;
  2. Redevelopment or CDBG eligible areas;

3. Areas consistent with the City's mixed Income Housing Ordinance.

On November 18, 2003, the City received an application from the representative of Tony's Food Finds requesting an award of 4.59 sewer credits to be used at 800 "H" Street. Award of the requested 4.59 sewer credits will reduce total Regional Sanitation fees to be paid for this project from \$10,621 (at \$2,314 apiece) to approximately \$4,237 (at \$923 apiece).

Based upon a review of the application (Attachment 1), staff concludes that the applicant meets Council-approved objectives for the granting of sewer credits by creating new employment.

The award of 4.59 sewer credits to Tony's Food Finds will leave a total of 6,079.40 sewer credits for future award by the City to support economic development projects.

Attachment 2 provides a summary of City Economic Development Department sewer credit award activity to date.

**FINANCIAL CONSIDERATIONS:**

Approval of the resolution imposes no additional expense upon the City beyond the minimal administrative costs associated with processing the approved credits.

**ENVIRONMENTAL CONSIDERATIONS:**

This project is subject to the environmental review process as part of the approval of its development application.

**POLICY CONSIDERATIONS:**

The City of Sacramento views projects that create new employment opportunities as an important cornerstone of the City's economic development. Additionally, the City of Sacramento supports the development and success of new and existing businesses of all sizes. Approval of the subject recommendation serves to promote this City policy objective.


**ESBD CONSIDERATIONS:**

No goods or services are being purchased.



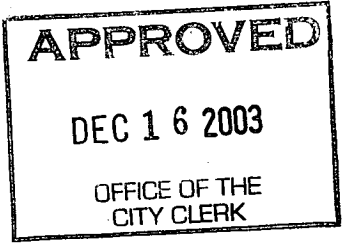

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO THAT:**

WHEREAS, on March 20, 2001, City Council authorized the City Manager to sign a Memorandum Of Understanding (MOU) to initiate City participation in the Sacramento Regional County Sanitation District Economic Development Treatment Capacity Bank (CC2001-177);

WHEREAS, eighty five percent (85%), or 6,775 of the total 7,971 ESD's (Equivalent Single-family Dwelling units) made available to the City of Sacramento under the MOU are allocated for economic development projects, the award of which must be approved by City Council resolution;

WHEREAS, Tony's Food Finds located at 800 "H" Street in Sacramento meets City economic development objectives by creating new employment.

NOW THEREFORE, be it resolved by the City Council of the City of Sacramento, as follows:

1. City Council hereby awards a maximum of 4.59 ESD credits from the Sacramento Regional County Sanitation District Economic Development Treatment Capacity Bank to Tony's Food Finds located at 800 "H" Street in Sacramento (APN: 006-0035-012).
2. Any and all credits awarded herein to each individual recipient shall expire if said individual recipient has not paid its requisite sewer impact fee to SRCSD within one-year from the date of approval of this resolution.
3. Any and all credits awarded herein to each individual recipient will expire if said individual recipient has not been issued a building permit for its
